This addendum is being issued to address and or clarify the following requirement in the City's bid for monitoring services for disaster debris removal:

Page 16 Bid Submittal Requirements Section 5 Contractor Qualifications point e) states
provide client's letters of satisfactory or better performance. On page 17 Section 9 states
attach minimum three letters of reference from past clients. To clarify, aren't these two
items the same thing? If so, which section should they be provided in on the proposal
response.

ANSWER: Yes, it is the same information. Provide this information in Section 9. No need to duplicate it in Section 5.

2. Page 17 Bid Submittal Requirements Section 10 Other Required Documents: Did not see documents in RFP for W-9, Immigration Act Compliance and E-Verify. Are these required? If so, will City of Foley issue them in an addendum?

ANSWER: A W-9 is not required at this time and should have been removed from this section of the bid. An immigration compliance affidavit is provided in this Addendum. This form can be submitted with the bid packet or the proposer may submit a copy of their E-Verify Memorandum of Understanding with the Department of Homeland Security.

3. Page 17: Bid Submittal Requirements Section 10 Other Required Documents: Please confirm which other required documents need to be submitted with proposal response.

ANSWER: This section ended with the word "etc." and was included in the event that something specified elsewhere in the bid packet had been left off this list.

4. Since Addendum #1 waived all bonding requirements and need to submit proof of insurance with proposal response, will the City adjust the second page of the Bid Submittal Form and eliminate/delete those particular items?

ANSWER: This question refers to page 19 of the bid packet. At this time, the City will not adjust the second page to remove the references to bonds and proof of insurance. Proposer can mark the appropriate acknowledgement statements as "Not Applicable" or "N/A"
