Question 2: The attachment labeled "Lead-Based Paint" is the Asbestos Report. Please upload the correct document. Also, the Asbestos Report for Project #1 @ 123 E. Main St. does not appear to be complete. Could you please upload the complete report? Thank you!

Answer 2: A correct Lead-Based Paint Test Report has been uploaded. Per Neighborhood and Family Services, they are in the process of obtaining a new report. A copy of this report will be posted here as soon as it's available.

Question 3: We received an invitation to bid on the Façade improvement projects in Avondale and I just had a question about the awarding for the job(s). Will there be a selection based on the overall low bidder for all of the projects collectively? Or will it be the low bidder for each of the projects individually?

Answer 3: Evaluation is based on section 2.18.2. It is City's intention to make one single award on all locations, but the City may, as it's discretion, accept multiple offers if it's the most advantageous to the City.
