Questions Received:

- **Question #1:** Will the contractor be expected to pick up the poles from the City's site or will the City deliver the poles?
- **Response #1:** The poles are located at Edison Electric's laydown yard (City contractor) and will need to be picked up by the contractor.
- **Question #2:** Will the contractor be expected to assemble the light to the pole?
- **Response #2:** Yes, the contractor will be expected to assemble the light/fixture to the pole.
- **Question #3:** On the bid schedule, the unit price for the Lighting Duct 35.11 shows 220 LF but then is limited to 10 LF per pole. Does that mean that we would only get half of the cost per pole?
- **Response #3:** The contractor will be paid per the Contract Unit Price per linear foot of duct installed between the transformer and the light pole. Since the light pole cannot be placed greater than 10' from the transformer, this would yield a maximum pay item of 10 feet x 22 poles, or 220 LF.
