RFQ 20-007 – Pest Control Services is hereby amended as noted herein: BIDDER TO ACKNOWLEDGE RECEIPT OF ADDENDUM BY SIGNING ON THE SIGNATURE LINE BELOW AND INCLUDING A COPY WITH SUBMITTED BID. FAILURE TO DO SO MAY, AT THE OWNER'S DISCRETION, SUBJECT THE BIDDER TO DISQUALIFICATION

1) <u>QUESTION:</u> Who is your current supplier and what are the annual spends by pest control and specifically for termite control?

<u>ANSWER:</u> Currently, the County utilizes Cingo, Ideal Pest Control, and Yates Astro. Approximately \$900/month is spent on monthly pest control services, and approximately \$4000.00 has been billed in the past year for termite services/bonds. We have not renewed some in anticipation of this RFQ.

- 2) QUESTION: Will technical proposals be accepted to determine capabilities of vendors? ANSWER: No, we just need the information requested in the RQ and the completed fee sheets.
- 3) **QUESTION:** Are we able to do any site inspections? And if so, who can we coordinate these with?

ANSWER: Contact information is below.

- 4) <u>QUESTION:</u> What is defined as termite control? <u>ANSWER:</u> I understand it to be an initial treatment of the building to prevent termites, with an annual payment for the termite bond, or coverage.
- 5) <u>QUESTION:</u> If termite infestation is found, are we able to provide separate pricing for treatment? As this is calculated by linear foot treated, would be challenging to bid it off total square footage as that is not usually necessary.

<u>ANSWER:</u> The updated fee sheets include the linear footage. If an infestation is found, the County can work with the awarded bidder to move forward with treatment.

6) QUESTION: Please define what is meant by Termite Bond on the pricing sheet. Is this meant to be cost of treatment? Can this be adjusted to linear foot versus square footage, as that is more common. We aren't sure what is meant by this and believe the attached agreement as this should cover our program as related to termites.
