ADDENDUM #1

Scope of Work

Contractors shall provide product specifications related to the type of netting to be installed along with the mechanism to reduce storm/wind damage inside their bid packet.

- 30 net systems total
 - 210 linear feet each
- 6,300 linear feet total
 - ~~2,700 3,600~~ linear feet 15 feet tall minimum
 - ~~3,600 2,700~~ linear feet 12 feet tall minimum
- Must use existing foundations at 30 feet spacing **with sleeves that accept a and 4 inch diameter OD post.**
- **Eleven (11) foundations have been compromised and will require repair/replace. This cost shall be included in the total project cost on the bid price sheet. Unit cost to repair/replace shall also be included on the price sheet in the event that additional issues are found. ~~Must include price per foundation for any existing foundations that need to be repaired/replaced.~~**
- Do not include removal of existing netting/structures in price. This work **is being done has been completed** by City forces.
- **Post must be black powder coated.**
- Contractor is encouraged to make a site visit prior to submitting bid. Please contact Rhett Brown at rbrown@cityoffoley to schedule a site visit.
- Installation must be included in price.
- Netting material must be heavy duty nylon and UV treated for outdoor use. **Netting material shall be a minimum of 325 pound break strength.**
- 1.75 inch minimum mesh size of nets for lacrosse or other similar events.
- Must include mechanism to eliminate or reduce storm/wind damage in the event nets are not lowered.
- Minimum of 4 inches of clearance from turf to bottom of net for turf maintenance. (i.e. line trimming)
- Must provide pictures, **specifications and any other information to clearly describe the** mechanism used to lower/raise netting.
- **Photos of previously installed netting that is the same as that being proposed by the bidder is encouraged to be provided in the bid response to indicate to the City what can be expected upon completion of this project.**
- Must have ASCE 7-10 wind rating up to 105 mph.
- Contractor shall estimate the timeframe for completion of this project by noting the number of working days required on the price sheet. This will be taken into consideration when establishing the contract period for the project.
- Contractor shall include in their bid the cost of any ancillary materials, special tools or equipment that are necessary to complete this project per these specifications and as directed by the City.
- Contractor is responsible for storage of all materials prior to and during construction/installation.
- Any and all deliveries must be coordinated and received by contractor.
- A site supervisor must be present to oversee the project.
- Repair of any damage sustained to the facility during construction is the responsibility of the contractor. Materials used in the repair shall meet or exceed the quality of the existing material.



- Contractor shall be responsible for complying with applicable safety requirements for his workers and others.
- Contractor shall clean up and dispose of all debris that is the result of this project.
- Bid price shall include materials, freight, installation and any other miscellaneous charges.
- Bid price shall be constant for a period of 120 days.
- Project award will not be based solely on the overall project price. Other considerations will include, but will not be limited to, the product quality and the mechanism for raising and lowering the netting. At a minimum, products to be provided shall meet or exceed the quality of the owner's current netting and net accessories.
- Provide three references for similar products.

Owner Responsibilities:

- Owner shall provide access to the site.
- Owner shall provide staging area adjacent to jobsite for materials and equipment.

Contract Period

The work shall be completed within six weeks of the date specified in a Notice to Proceed issued to the Contractor by the Owner, or its authorized representative. ~~The number of working days shall be mutually agreed upon by the awarded contractor and Foley Sports Tourism. The number of days will be stated in the Notice to Proceed and the contract documents.~~ The current tournament schedule will have to be taken into consideration during completion of the work.

It is mutually agreed between the parties hereto that time is of the essence in regards to this Contract, and in the event the construction of the Work is not completed within the agreed upon timeframe, it is agreed that from the compensation otherwise to be paid to the Contractor, the first party may retain the sum of **One Hundred Dollars (\$100.00)** for each day thereafter, Saturdays, Sundays and holidays excluded, that the work remains uncompleted, which sum shall represent the actual damages which the Owner will have sustained per day by failure of the Contractor to complete the work within the time stipulated, and this sum is not a penalty, being the stipulated damages the first party will have sustained in the event of such default by the second party.

If a working day is lost due to inclement weather or other unforeseen event, the contractor is encouraged to submit this information at the end of each working week to the Sports Tourism Director or his designee. These days will be taken into consideration relating to the required completion period. In the event that the contract working days are exceeded without proper notification of lost days due to inclement weather or other unforeseen event, the City may choose to enforce liquidated damages.
