3. **ONLINE SUBMISSIONS ALLOWED:** In addition to acceptance of sealed bids received in person, the City will allow online submissions of the bid. TO MEET THE LICENSURE REQUIREMENTS, ENSURE THE ATTACHED DOCUMENT “2020 Resurfacing Phase II – Outside of the Envelope” is submitted as **one single PDF document** in addition to all other required forms submitted as a complete, separate package. The following instructions provide the process for submitting your bid online. Submitting online does not excuse the requirements for submissions of bids by 11:00:00 a.m. and no late bids will be accepted.

In addition to submission procedures listed within this solicitation document, the City provides the option of electronic submission. To submit your proposal/bid electronically, please follow the detailed instructions below.

Electronic Submission Procedures:

Electronic submissions shall be submitted online through the City’s Procurement website. If submitting online, DO NOT EMAIL YOUR SUBMISSION. All bidders must register as a vendor in order to submit an electronic file.

Step One: Register as a City of Knoxville vendor

(Vendors are encouraged to complete this step **now** to ensure seamless submission

process prior to deadline.)

To register as a vendor:

Visit the website at www.knoxvilletn.gov/purchasing

Click the “Vendor Registration” tab; then “Click here to register as a City of Knoxville Vendor” Follow the prompts to complete online registration.

Note: You will be asked for a PIN. This PIN will be emailed to you and may have been sent to your spam or junk folder.

DO NOT WAIT UNTIL SUBMISSION DEADLINE TO REGISTER AS A VENDOR. The electronic submission link will be disabled at 11:00:00 a.m. Eastern time. Vendors will not have the ability to submit any electronic files once the deadline has passed.

Step Two:

Submit all materials electronically as two (2) files (Outside of the Envelope and Bid Package) to City’s Procurement website PRIOR to **11:00:00 a.m.** (Eastern Time) on **April 1, 2020.**

To submit electronic file:

Visit the procurement website at www.knoxvilletn.gov/bids

Click “2020 Resurfacing – Phase II”

Click “Submit Bid” (red button located at top of screen)

Follow the prompts to upload and submit electronic files.

Submit both the Outside of the Envelope document and your Bid Package

Files **MUST** use the following naming convention and be named as the firm’s name, followed by the title of the project, followed by either Outside of the Envelope or Bid Package.

Example: PennysConstruction-2020 Resurfacing Phase II-Outside of Envelope.pdf or PennysConstruction-2020 Resurfacing Phase II-Bid Package.pdf

Should you need to merge multiple documents into one PDF, please utilize Google to download a free software intended for merging pdf documents.
