**Question #1:** Do you know if there were changes made to drawings from the first bid?

**Response:** There were no changes made to the civil design drawings from the first

bid.

Question #2: The contract drawing and bid form states to provide "952 LF OF 6' TALL

2"-9 GAUGE ALUMINUM CHAIN LINK PERIMETER FENCE", and

two each 20' rolling gates. Can a galvanized chain link fence be

substituted?

**Response:** Yes, 6' Tall Galvanized (Class 2) 2"-9 Gauge Chain Link fence and gate

may be substituted. The following additional specifications shall apply:

• Schedule 40 posts.

- Three (3) rows of galvanized barbed wire along the top.
- Top Rail.
- Bottom tension wire.

### **Question #3:**

Please provide clarification as to the requirements for the utility structure (oil Shed structure). The bid document state a 30'x16' partially enclosed oil shed structure is required. Included with the bid documents are approximately 29 pages of Custom Built Structures drawing. These drawings include every type of building and component that Custom Built Structures sales. Nowhere in the documents are there any design details stating what is required for this 30'x16 partially enclosed oil shed structure.

We contact Custom Built Structures multiple time to obtain pricing, prior to the last bid, and they never responded.

Please provide details as to the requirement for the 30'x16' partially enclosed oil shed structure so that we may obtain pricing.

Details should include height of the structure, define which walls shall have wall panels, heights of the wall panels for the partially enclosed structure, gauge of metal wall and roof panels, define if roof and wall panels should receive painted or galvanized coatings, etc.

### **Response:**

The example provided in the bid documents prepared by Custom Built Structures is a typical example. The county recently purchased one of these from Custom Built Structures. The invoice is attached, which contains the dimensions and selected options. This is the same structure that is specified for this project. Also, photos of the installed structure are below (Note: A sump is required in the slab for this project, per Drawing C-13). The contractor may submit to the County for approval an "approved equal" structure from another supplier, provided that it is stamped by a licensed PE for wind loading/structural.

#### **Revision:**

Under Page 7, <u>BASE BID</u>, sentence two should read as follows: "The utilities will include, but not be limited to, installation of storm pipes and structures, installation of new water service line, installation of a new sewer grinder **and small diameter force main** and installation of electrical systems."
