Project: Avon Park Health Department Sidewalk and Parking Improvements ADA

Transition Plan

This addendum is being issued to revise an item on the bid form and to answer a question received at the Pre-Bid Meeting.

- 1. Task #12 on the bid form has been revised. The steel pipe guiderail is being deleted and an aluminum guiderail is to be installed. The specification, drawing notes, and tabulation of quantities have been revised. The Bid Form has been revised reflecting the change to the proposed guiderail material. Bidders are to use the revised Bid Form attached to this Addendum.
- 2. A copy of the Non-Mandatory Pre-Bid Meeting Sign In sheet is attached.

Questions and Answers

Will the steel guiderail be painted or finished?
 Answer: See item 1 above the guiderail material has been revised.

2. The sidewalk in front is being repositioned for what purpose?

Answer: This sidewalk is being repositioned due the fact that under existing conditions the sidewalk goes from a 'flush' condition adjacent to the asphalt parking lot, to a 'raised' condition as it approaches the sidewalk connection in the S. Lake Avenue right-of-way. To eliminate the need for removing asphalt or adding a curb to make the proposed sidewalk ADA compliant, the engineer calculated that it would be more cost effective to reposition the existing sidewalk over as part of the design.

3. Plans don't define were the 6" concrete is and where the 4" concrete thickness is located. Please indicate?

Answer: See attached revised plan set. The southern proposed sidewalk (closest to the parking lot) is proposed to be 6" thick. The other two sidewalk replacement areas are proposed to be 4" thick, as depicted on Sheet 11 of 12 of the revised plan set.

4. Handrail on existing sidewalk but it does not show a grade. Is this handrail being added because the sidewalk is sloping?

Answer: Yes, the Contractor is only providing the handrail for the existing sidewalk which has a slope that necessitates a handrail, per ADA criteria.
