- 1. Addendum 2 is issued to inform all companies that have a copy of RFP 5303-01, Inmate Commissary Services at the Jackson County Jail of the following questions and answers that have been received by vendors.
- QUESTION: Can you provide commissary sales for the last three months? ANSWER: \$53,026.86 all see detail sales in Addendum 1
- QUESTION: May we have a copy of the current commissary menu with pricing? ANSWER: See attached menu.
- QUESTION: What is your current commission rate? ANSWER: 28%
- QUESTION: How many inmate kiosks are currently in each dorm? ANSWER: See Addendum 1
- QUESTION: What is the current fee on the lobby kiosk? ANSWER: \$3.25
- QUESTION: Who is the facility's current food vendor? ANSWER: Correctional Resource Group
- QUESTION: Will the Jail be purchasing indigent and/or admission kits from the commissary vendor? If yes, please provide a list of products (with sizes) included in each kit, and the price of each kit. ANSWER: Yes see attached list.
- QUESTION: Can the County please provide the current commissary list with pricing? ANSWER: See above answer.
- QUESTION: Please provide the sales, less phone time or tax (net of), over each of the last three full commissary months. ANSWER: See Addendum 1 and above answer.
- QUESTION: What is the current commission rate? ANSWER: 28% Does the County receive the same commission rate on all categories of items (excluding postage)? ANSWER: Yes.
- QUESTION: How many individual inmate orders were delivered per month for July, August and September? ANSWER: See attached.
- QUESTION: Does the jail currently utilize any package programs? ANSWER: No.
- QUESTION: What is the spending limit per inmate per order? ANSWER: \$50.00 limit per order.

- QUESTION: How do inmates purchase phone time? ANSWER: Money from the inmate's account is placed on the phone service vial the kiosk in the pod(s).
- QUESTION: Would the county be more interested in selling electronic phone time, eliminating the need for phone cards? ANSWER: No.
- QUESTION: Does the jail currently utilize any type of deposit services? ANSWER: See attached.
- QUESTION: Is the vendor required to provide an armored car service for cash pick-up? ANSWER: No.
- QUESTION: Does the jail utilize any other programs in which inmates purchase food items outside of commissary? ANSWER: No.
- QUESTION: Who is the current food service provider? ANSWER: See above answer.
