Grounds and Landscape Maintenance for Bathsheba Bowens Park, Futrell Park and Garden of Hope Park

The purpose of this Addendum 001 to RFP 23-R0014 for Grounds and Landscape Maintenance for Bathsheba Bowens Park, Futrell Park and Garden of Hope Park, dated November 18, 2022, is to provide clarification to comments/questions received.

- It is the intent of this RFP to establish a term contract for Grounds and Landscape Maintenance to be performed on a year round basis at the following locations.
 - o Bathsheba Bowens Park located at 840 Nance Street, Myrtle Beach, SC.
 - o Futrell Park located at 1100 Mr. Joe White Avenue, Myrtle Beach, SC.
 - o Garden of Hope Park located at 1402 Dunbar Street, Myrtle Beach, SC.
- Bonds are not required for this project.
- The price of the current contract is \$2,036.15/month. In addition to the current contract price sixteen (16) garden plots are maintained at a total of \$743.05/month.
- Additional Pricing Request for Garden of Hope:
 - The garden plots are available to the public. In the event that all plots are not utilized, please provide pricing to maintain garden plot(s) on a year round basis.
 - Alternate #1 shall be the annual cost to provide grounds and landscape maintenance services for each plot that is not utilized and the contract price will be divided into twelve (12) equal monthly payments.
 - See Revised Price Schedule that is attached and hereby made a part of this addendum and replaces "Price Schedule (page 38)" in the Proposal Requirements.
