Question 1: We are requesting a contact person who can provide access to the gate/road from Brick Chimney Rd to the County landfill for muck hauling as provided in specification section 27.

Response: (27) SECTION 203: MUCK EXCAVATION shall be changed as follows:
Remove and replace the fourth paragraph with the following.

“The contractor may be directed by the County to dispose of some or all of the unsuitable soil material at the County Landfill. Contractor shall not utilize the IP Canal access road to the landfill. There will be no additional compensation for this. ”
