#### Questions and Answers.

- Highlighted at the end of 4.0, the solicitation says that a current SF330 shall be included. Can you confirm that you only want the SF330 Part II, not Parts I and II? Provide parts I & II
- 2. In section 4.0.4.A, it references design services for a gymnasium. Is this actually relevant to this solicitation?

  In Section 4.0.4 item a) remove "(gymnasium)".
- 3. We saw on page 18 of the solicitation under "Project Team Performance, Past and Current", that there is a request for design services from gymnasium projects for this section? Is this correct? Our impression is that the solicitation is for projects needing completion under you capital improvements lists, not strictly gymnasium work. In Section 4.0.4 item a) remove "(gymnasium)".
- 4. Also, could you tell me if there is a page limit to this response? No page limit.
- 5. 4.0.5 e) requires "Qualifications of key consultants identified in the **Official Proposal Form**" [Emphasis mine]. Will you please identify which part of the RFQ is considered the "Official Proposal Form," or otherwise identify where we can obtain this form? This is not an actual form. Please list this information in your official proposal.
