QUESTIONS BY CONTRACTORS

The following questions have been posed by potential bidders for this project. The clarifications are provided for information only and are not made part of the Contract Documents. Where necessary, modifications to the Contract Documents have been made by addenda.

1. *QUESTION:* Is a record of topics covered in the Pre-Bid Meeting and Sign-In Sheet available?

CLARIFICATION: The Pre-Bid Meeting Minutes and Sign-in Sheet was included in Addendum No. 3.

2. *QUESTION:* What is the procedure for conducting a pre-bid visit?

CLARIFICATION: Meet Randy Taylor at Moccasin Bend Wastewater Treatment Plant on Monday, August 15, 2016 at 10:30am at the Training Facility.

3. *QUESTION:* Can the Bid Opening date be extended?

CLARIFICATION: The bid opening date was extended in Addendum No. 3.

4. *QUESTION:* Can Paragraph 7.01 of the Instructions to Bidders which states "Questions received less than ten days prior to the date for opening of bids may not be answered." be reconsidered due to compressed time schedule for bid preparation?
