ANSWERS TO SUBMITTED QUESTIONS

ADD-1 Item No. A-1 - Question regarding the deadline for pre-bid questions

Question: What is the last date/time for questions regarding this project?

Answer: *The deadline for questions is Sunday August 8 @ 5PM. Addendum No. 2 will be released on Monday August 9, which will be the final Addendum. Note: As the pre-bid meeting is scheduled for August 5 at 2PM, bidders are encouraged to submit any subsequent questions as soon as possible based upon the August 8 deadline.*

ADD-1 Item No. A-2 - Question regarding camera numbering sequence and quantities

Question: I am inquiring about the camera number sequence. I see there are 80 cameras listed, is that correct? And is the numbering sequence correct?

Answer: *The numbering sequence listed in the camera schedules has been updated as part of this Addendum. Bidders shall refer to drawing sheet floor plans and schedules to determine the quantity of cameras required.*

ADD-1 Item No. A-3 - Question regarding alternative camera manufacturer

Question: I am from [name removed] Security and we specialize in badge access control and camera surveillance. I was reading through the RFP and noticed that you guys have spec'd Avigilon cameras. Would you potentially be open to using our cameras?

Answer: *No, the Owner's standard is Avigilon. The spec does not allow for alternates.*

ADD-1 Item No. A-4 - Question regarding access at the job sites

Question: What days of the week and work hours will be allowed at the job sites?

Answer: *For Middle and High Schools, the contractor may start work at 3:30PM. For Elementary Schools, the contractor may start at 4:30PM. Work may be performed until building custodial staff leave for the evening. Weekend work may also be arranged with the Owner. Bidders are reminded that all fees associated with second shift and potential weekend work shall be included in their base bid.*

ADD-1 Item No. A-5 - Question regarding mounting accessories for 360 multi-sensor cameras

Question: I am requesting confirmation that there aren't any mounting accessories required for the 360 multi-sensor cameras. Normally I might add:

H4AMH-AD-CEIL1 ceiling mount and/or H4AMH-DC-COVR1 bubble & cover in ceiling

It appears that some of the 360 are hard-deck and some are drop tile ceiling mounts. Thank you for the clarification.

Answer: *For 360 multi-sensor cameras, the camera contractor shall provide the CEIL1 version of the Avigilon ceiling mount.*

CHANGES TO DRAWINGS**ADD-1 Item No. D-1 - Added camera ID numbers to floor plans**

Refer to Sheet(s): T 101C, T 101D, T 101F, T 102J, T 111B, T 111C, T 111D, T 111E, T 111F, T 112A, T 112B, T 112C, T 112D, T 113C, T 113D

The camera schedule for each building holds a unique camera ID per location on the floor plans. The unique camera ID number, that links each camera back to a specific line item on the schedule, is now shown on the drawings listed above. All quantities of cameras remain the same and none have been added nor deleted from the project.

ADD-1 Item No. D-2 - Floor Plan Unit Names adjustment on sheet

Refer to Sheet(s): T 101E, T 101J, T 102D

Floor plan unit names have been adjusted, on the drawing sheets listed above, to fit on the sheet.

ADD-1 Item No. D-3 - Removed Mounting Height column from Building Camera Schedules.

Refer to Sheet(s): T 104, T 114, T 122, T 132, T 140

Camera heights, originally indicated in the mounting schedule, shall be disregarded and have been removed from drawings. Camera heights will follow either a) existing rough in locations where camera is being replaced 1:1, or b) shall be coordinated post-award.
