Addendum 01 May 19, 2022 IFB 22-B0043 Grand Linear Park Pedestrian Bridge

The purpose of this Addendum 01 to IFB 22-B0043 for Grand Linear Park Pedestrian Bridge, dated May 2022, is to list the key points of discussion from the mandatory pre-bid meeting.

- The prefabricated bridges will be installed in a remote area that is not easily accessible by crane. Therefore, the Contractor will need to consider a variety of bridge formations. Additional information regarding bridge formation can be obtained by contacting:

- The 120-day performance period is flexible due to supply chain issues. Contractor will be responsible for continuous communication with the City regarding project timeline.
- There is little to no staging area available at the site. There is a small parking lot in front of the Thunderbolt Park building that could be used as a staging area if needed.
- Heavy equipment can use the asphalt path around the lake. Access points are located at Thunderbolt Park and ITAP. The path is ten feet wide, with two inches of asphalt on a ten-inch coquina base. The Contractor will be responsible for any damage caused to the path, with any damage repairs to be made at the Contractor's expense. In addition, the City will not be responsible for any damage or loss of heavy equipment while using the path.
- Contractor is advised that there may be other projects going on in the area during the same time frame as this project.
- Additional questions are due no later than close of business on Tuesday, May 24, 2022. Questions may be submitted via e-mail to asowers@cityofmyrtlebeach.com All questions received by the deadline will be answered via addendum on May 31, 2022.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Tuesday, June 14, 2022. No electronic submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.
