Landscaping

The following questions have been asked and answered:

A. Bathsheba Bowen

1. Are we responsible for taking care of the ditch that goes along the walkway?

Yes, you are responsible for taking care of the ditch that goes along the walkway. Maintenance for the ditch would be trimming/weed eating the ditch and picking up trash that is thrown in the ditch.

B. Futrell

1. Most of the mulch areas have lots of sticks and pine cones in them. Are we responsible for cleaning them up?

Yes, picking up the sticks and pine cones from the mulch areas will be part of the requirements.

2. There are lots of pine straw in the beds at this point. Would it be better to go with pine straw instead of mulch?

No, pine straw is prohibited and we understand with all the pine trees the straw will be hard to remove, but mulch will still have to be installed.

3. Grass had lots of weeds. Are we responsible for cleaning up all the weeds that are currently there?
You just need to follow the specs with the herbicide treatment. Due to the Park not having a working irrigation system we understand about the weeds. We just ask that you keep the grass/weeds mowed for a decent appearance.

4. Some areas have no grass at all just weeds. If we spray those areas they will be bare. Are we going to be responsible for laying new sod in these areas?

No, but the extra work feature of this contract could be used if the City would want to lay new sod in an area.

5. Do we mulch areas where azaleas are at the pump house, or is that part of the apartments?

Yes, the large bed at Pump House is part of the park, up to the sidewalk at the apartments.

6. What needs to be done where the wax myrtles were cut out?

If the area needs to be raked or cleaned better that would be required. This was caused by Hurricane Matthew damage to the trees.

C. Garden of Hope


1. Are we just responsible for the area inside the light poles, or does the lot next door need to be maintained also?

The Garden of Hope runs from the paved parking lot area over to the wood bollards, down the fence of resident's property, up to the sidewalk curb and over to the natural area. The natural area is where we ask you to maintain the weeds from coming up.

2. Are we responsible for the trash that is being thrown out of the garden areas?

Yes, you will need to pick up anything that has been thrown out into a walk path or park area that a garden plot renter did not pick up.
