The following changes shall be made to the Contract Documents, Specifications, and Drawings:

I. Questions and Answers

Q: Is a volume breakdown available?

A: There should be a breakdown on the flashdrive. We estimate 50,000 is accurate.

Q. Is the no. of units per lot or the whole project?

A. The units are combined estimate of lots forecasted.

Q. How are you wanting us to crack prep for crack fill/removal of vegetation?

A. Hot air lance and graser cart.

Q. How is billing being handled?

A. Billing is being handled on a completion basis per project site

Q. Are handicap signs in bollards?

A. Handicap signs are not in bollards

Q. U-Channel or square posts for signs?

A. U-Channel

Q. More clarification on when work can be completed?

A. Work can be completed as weather/climate allows. Some sites might have special circumstances, such as City Hall Parking area. YFD Center at Glenwood could also require special circumstances.

Q. Responsibility for cars left?

A. City would handle it similar to paving projects, meaning the contractor is responsible for putting out a notice 48 hours before work begins. We do not start towing until the first day work is scheduled. The City coordinates the towing.

IMPORTANT TO NOTE:

Squeegee of first coat cannot be done by hand - you have to use a squeegee machine. New Bid Schedule attached.
