1. Construction water is available from City at no charge. However, the contractor is required to get a meter from the City. What is the amount of the deposit required for the meter?

Meter deposit is \$500

2. Can the inside area of the tank site be used for stored material?

Construction staging will be allowed within the fenced area of the tank site and a cleared area immediately east of the tank site. The area inside of the tank site can be used for stored material. The contractor is required to coordinate with the City to ensure sufficient storage area is available and there are no interruptions to the City's operations or delivery of 1-ton chlorine tanks.

3. Is a domestic certification for American Iron and Steel (AIS) requirements applicable to this project?

No AIS certification is required on this project.

4. Will additional time be added to the construction contract after the condition of the roof/rafters are evaluated?

After the condition and evaluation results of the roof and rafters is determined, the City will work with the contractor to determine if additional time is needed or if the work can be done within the allotted contract time.

- 4. Project scope:
 - Refurbishment of the Johnson Hill East tank including new paint system, inlet/outlet piping, overflow/drain piping, access, floor, vent, level indicator, and cathodic protection systems.
 - b. Improvements to the overflow/drain piping.
- 5. Bid proposal: A base bid and two (2) additive alternates. (Section 00400, Page 5)
- 6. Comparison of bids: Bids will be compared based on the total sum of the base bid and all alternatives. (Section 00300, Page 14)

Bidder must submit a copy of the valid preference certificate issued by the NM Taxation and Revenue Department.
- 11. Section 00400, Article 7 on Page 7 lists documents that must be submitted with the bid package.
- 12. The project area is located within property and right-of-way owned by the City of Portales.
- 13. The contractor is responsible for quality compliance and acceptance testing of material, process, and methods of construction. (General Notes 16 & 17, Sheet 1-5)
- 14. Construction water is available from the City at no charge. However, the contractor is required to get a meter from the City. A deposit is required for the meter. (General Note 23, Sheet 1-5)
- 15. Construction staging will be allowed within the fenced area of the tank site and a cleared area immediately east of the tank site. When staging within the tank site the Contractor shall provide access necessary to enable operation of the facility; including replacement of the 1-ton chorine tanks, which are restocked monthly (General Note 22, Sheet 1-5). The contractor is responsible for establishing any other necessary construction staging yard. The cost is considered incidental to the project.
- 16. There is no geotechnical baseline report. (Section 00300, Page 4) It is anticipated that bedding and backfill gradation requirements can be met using native material. Class I, II or III backfill material as defined in Detail 1 on Sheet 2-1 is allowed.

- 17. The tank site must remain active during the period of construction. To facilitate its operation, the sequence of work outlined in Specification 01 11 00 must be adhered to by the Contractor.
- 18. Survey control points are provided on Sheet 3-1.
