1. Question:

Page 70 of the RFP and Addendum 1 show the current Experience Modification Factor as .98. 10/1/19 WC Mod was .99 and 10/1/20 WC Mod is 1.01. Please clarify what mod we are to be using for this proposal.

Response - Village: The Mod should be 1.01

2. Question:

Page 16 of the RFP Section 4.0 current program – real and personal property contents limit: The Village endorsed an additional \$ 50,000 worth of contents on 11/19/19 to location 015-001 (Meeting Hall). This brings the total contents value up to \$ 1,157,180 from \$ 1,107,180. Please confirm the contents limit should be \$ 1,157,180.

Response – Village: The contents limit should be \$ 1,157,180.

3. Question:

Automobile – Physical Damage coverage was added to vehicles 25 and 26 by endorsement. Shall the Village issue an addendum reflecting the correction?

Response – Village: Yes, please refer to #3-2 (.pdf)

4. Question:

There are a few questions we need for underwriting purposes:

Claim GC2019093715 (07/23/18) – Wayne Rosen, we need a brief description of the claim. Claim GC2019094119 (04/03/19) – Property Claim, we need a brief description of this claim.

Response – Village: The Wayne Rosen claim was dropped, and the Property Claim was an incident that occurred when someone broke into Village Hall and vandalized it.

5. Village - Statement: Please review #5-2 (.pdf) – these are the latest Workers Compensation Experience Rating.
