**Bid Opening**: All Bids **MUST** be received by the city's purchasing department located at 101 East 11th Street, Suite G13, Chattanooga, TN 37402 no later than **2:00 PM** on **Tuesday, March 31, 2020** in the Purchasing Conference Room.

Comment 1: The bid opening date for this contract has been moved to March 31, 2020 at the same time and location.

**Comment 2:** When submitting your sealed bid to Purchasing, you MUST include Form 00201, Contractor's ID on the outside of the envelope. See the form below. **NO** bid will be opened without this form completed on the outside of the bid package envelope.

**Comment 3:** Work zone permit application for any work shall be submitted 2 weeks ahead of requested work date.

**Comment 4:** Any work not taking place under the same closure i.e. manhole adjustments, signal loops, milling, must have a separate work zone permit which shall be submitted 2 weeks ahead of requested work date

**Comment 5:** There is a 15% DBE goal for this project.

Comment 6: Attached is Form 8-5 (DBE Participation) that must be completed by the contractor and submitted to CDOT and TDOT within 3 business days of the bid opening. A bidder must be on TDOT's Small Business Development website to be considered for DBE participation. We have also attached a SAMPLE of a completed Form 8-5 for your reference. **Comment 8:** This project is a TDOT Local Program Locally Let and Locally Managed project and must meet all requirements as such.

# The following are Comments, Questions, & Answers from the Pre-bid Meeting that was held on Tuesday, February 4, 2020, at 10:00 am – 1250 Market Street, Suite 3030, Conference Room 3B and questions received as of 2/13/20

**Question:** The bid schedule contains non-reimbursable bid items. Will the contractor be required to submit a separate invoice for the non-reimbursable bid items?

**Answer:** A separate invoice will be required to be submitted for the non-reimbursable bid items each month. If those items are not utilized in a given month, a blank invoice **will not** be required.

**Question:** Do the manhole adjustment items count toward the overall DBE goal?

**Answer:** At this time it is anticipated that the manhole adjustments will not count toward the DBE goal.

**Question:** Are block closures allowed on this project?

Answer: Block closures will be permitted with coordination and approval through the CDOT

Operations - work zone permit process.

**Question:** Will there be any stakeholder meeting required?

Answer: Due to the locations of this project some coordination with stakeholders will be expected

during this project.

**Question:** Will the City do its own inspection on this project?

**Answer:** The City will provide a Resident Project Representative to work with the CEI on this project.

**Question:** If the contactor subcontracts the manhole adjustment do they have to meet man-day requirements?

**Answer:** The manhole adjustment portion of the contract is not TDOT reimbursable.

**Question:** What is the completion date for this contract?

**Answer**: The project should be completed on or before December 1, 2020

**Question:** Will there be any conflicts with other projects?

**Answer:** A contract for replacement of bearings on the Bailey Avenue bridge is currently going through the procurement and approval process and should commence within two months of this addendum. The contractor should be aware of scheduling and traffic control conflicts for this project.

**Question:** Who is responsible for ensuring that sewer manholes do not get blocked from debris from the manhole adjustments?

**Answer:** The contractor is responsible to ensure that no material is allowed to drop into/remain in the manhole. This can be accomplished through the use of a grit catcher.

### **BID OPENING CHECKLIST**

- 1. No electronic bidding is allowed on this bid
- 2. Must be submitted in a sealed envelope/box
- 3. Contractor's license number not required (if federal funds are on the project)
- 4. Complete bid specs, as issued, are returned. Bid Proposal packages **shall** not be separated.
- 5. Only forms in the bid specs, as issued, are completed
- 6. Power of Attorney is dated within 3 days of the bid being signed
- 7. All addendums are to be acknowledged on the bid envelope or on the bid form
- 8. All addendums are to be included in the returned bid specs for the bid opening and must be stapled to the bound bid proposal package.
- 9. All line items on the bid form must have a number greater than \$0.00 assigned
- 10. No add alternates or deducts by contractors or local agency
- 11. Bidders must be TDOT pre-qualified to submit a bid
  - a. Bidders have a 90-day grace period once their pre-qualification status has expired so they are still eligible to bid
- 12. Form 8-5 (DBE Participation) must be completed by the contractor and submitted to Agency and TDOT within 3 business days of the bid opening
  - a. Must be on TDOT's Small Business Development website to be considered for DBE participation
  - b. It is recommended that this form be submitted by all bidders even if the bidder is not the apparent low bidder. In the case that a disqualifying requirement is not met by the apparent low bidder, the next bidder is still required to submit the form within 3 business days of the bid opening.
- 13. Any changes made on the bid form must be initialed by bidders
- 14. Ensure whomever signed the pre-qualification paperwork with TDOT signs the bid documents
- 15. All forms must be completed in their entirety (i.e. if there is a place to print name and sign, they must do both). Examples of forms include but is not limited to the Proposal Bond, Proposal Certification, and the Bid Form, etc.
- 16. Bid must be in NUMERALS and IN WORDS.
