As a result of inquiries, the following clarifications/changes are provided for your information. Please make all appropriate changes to your bid documents. Note: changes are reflected with original language shown with strike-through and new language is underlined.

- Q1: We hold a Florida State Building Contractors License. Do we still qualify to bid on this project?
- A1: No, A Florida State Building Contractors License does not meet the qualification requirement.
- Q2: According to Plans CONTRACTOR SHALL PROVIDE THE TELEMETRY SYSTEM RTU AND ALL REQUIRED SCADA EQUIPMENT. THE TELEMETRY SYSTEM SHALL BE AS APPROVED BY THE DISTRICT AND SHALL CONFORM TO THEIR STANDARDS. According to Technical Specifications: The pump station shall communicate via telemetry to the St. John's River Water Management District (SJRWMD). Telemetry shall be compatible with the SJRWMD's existing system. The SJRWMD shall have the ability to monitor and control the pumps. Question: What existing SCADA equipment and what existing RTU equipment does SJRWMD currently use?
- A2: Please refer to Volume 1 Electrical Legend Drawing G6 Note 11 and Volume 2 Electrical Legend Drawing E1-1 Note 11 for SCADA and RTU equipment requirements.
- Q3: I represent Grundfos submersible pumps & would like to know if you can point me in the direction of the proper personnel to talk with in regards to being approved equal for this project?
- A3: Review of equals or substitutions will occur after contract award.
- Q4: IFB paragraph 27, page 40, references that the Project must comply with the Davis-Bacon Act. Please supply the "General Decision Number" for Brevard County, for Building, Heavy and Highway.
- A4: The current **General Decision Number** is FL20220001 Modification #8. Here is the Sam.gov website that will show the most current Davis Bacon Wage Determination in effect. https://sam.gov/wage-determination/FL20220001/8 Also, please refer to Attachment 8, attached to this addendum.
- Q5: IFB (Cost Schedule) page 15, states that the "Award will be based upon items one through four"is this correct? Shouldn't it say one-through six?
- A5: You are correct. Please see revised page 15 attached to this addendum.
- Q6: Plan Sheet C 6-6.... Referenced on the drawing is a note that states that a Subsurface Utility and Engr. (SUE) repost is available for the intersection of St. Johns Heritage and US192/Coast Parkway, can this Report be made available?
- A6: The SUE reports are referenced from Specifications Section 01000, Paragraph 1.05, and are provided as Appendix B at the back of the Specifications PDF.

- Q7: What is the Questions End Date & Time?
- A7: Questions are due nine days before the bid deadline at end of the day. For this bid, the date is 8/30/22.
- Q8: Since Bids are being opened in Palm Bay, FL BUT we can submit on-line with Demand Star, how do we obtain the "Unofficial Bid Tab/Results"? Will you be sending them out right after the Bid Opening or will there also be a Virtual Bid Opening or will you have them Posted to Demand Star that same Day?

The Department, as a Non-Federal Entity as defined by 2 CFR §200.69, shall comply with the following provisions, where applicable. For purposes of this Grant Agreement between the Department and the Grantee, the term "Recipient" shall mean "Grantee."

Further, the Department, as a pass-through entity, also requires the Grantee to pass on these requirements to all lower tier subrecipients/contractors, and to comply with the provisions of the award, the SLFRF implementing regulation, including applicable provisions of the OMB Uniform Guidance (2 CFR Part 200), and all associated terms and conditions. 2. Termination for Cause and Convenience

Termination for Cause and Convenience are addressed elsewhere in the Agreement.

3. Equal Opportunity Clause

The following provision applies if the agreement meets the definition of "federally assisted construction contract" as defined by 41 CFR Part 60-1.3:

During the performance of this Agreement, the Recipient agrees as follows:

- A. The Recipient will not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, or national origin. - C. The Recipient will not discharge or in any other manner discriminate against any employee or applicant for employment because such employee or applicant has inquired about, discussed, or disclosed the compensation of the employee or applicant or
- D. another employee or applicant. This provision shall not apply to instances in which an employee who has access to the compensation information of other employees or

- applicants as a part of such employee's essential job functions discloses the compensation of such other employees or applicants to individuals who do not otherwise have access to such information, unless such disclosure is in response to a formal complaint or charge, in furtherance of an investigation, proceeding, hearing, or action, including an investigation conducted by the employer, or is consistent with the Recipient's legal duty to furnish information.
- E. The Recipient will send to each labor union or representative of workers with which he has a collective bargaining agreement or other Agreement or understanding, a notice to be provided advising the said labor union or workers' representatives of the Recipient's commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- F. The Recipient will comply with all provisions of Executive Order 11246 of September 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.
- G. The Recipient will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records, and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- H. In the event of the Recipient's noncompliance with the nondiscrimination clauses of this Agreement or with any of the said rules, regulations, or orders, this Agreement may be canceled, terminated, or suspended in whole or in part and the Recipient may be declared ineligible for further Government contracts or federally assisted construction contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- I. The Recipient will include the portion of the sentence immediately preceding paragraph (1) and the provisions of paragraphs (1) through (8) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. 4. Contract Work Hours and Safety Standards Act
