Addendum Number 1 is issued to provide changes and/or clarifications to the questions asked on the above referenced bid. Date, Time, and Location of submitting this bid remains unchanged.

General:

Questions and responses requesting plan clarification.

QUESTION 1

On Sediment material, I just want To confirm that sentiment material being removed from both job site are aloud to be dumped and stocked piled at East pond location?

ANSWER 1 SEDIMENT MATERIAL CAN BE STOCKPILED AT THE NORTHSIDE OF THE EAST BASIN AREA OR HAULED ELSEWHERE AT CONTRACTORS' DISCRETION

QUESTION 2 Is vegetation aloud to be stocked piled at east pond along with sediment material?

ANSWER 2 SEDIMENT MATERIAL CAN BE STOCKPILED AT THE NORTHSIDE OF THE EAST BASIN AREA OR HAULED ELSEWHERE AT CONTRACTORS' DISCRETION

QUESTION 3 Will there be days added to contract for rainy day?

ANSWER 3 ENGINEERS' ORIGINAL DAYS TO COMPLETE WAS 105 DAYS, DUE TO THE FACT THAT RAIN SEASON IS ALMOST HERE, I CHANGED IT FROM 105 TO 180 TO HELP COVER RAINY DAYS. QUESTION 4 Is a GF-4 going to be required for this project?

ANSWER 4

GF-4 IS NOT GOING TO BE REQUIRED BUT WILL BE ACCECTABLE TO PERFORM THIS JOB.

QUESTION 5

The required CID License shows GS-8 or GB-98. Please confirm licensing requirements. Previous city basin projects required GF-4 or GF-98 licensing, per NMAC 14.6.6:

ANSWER 5

GF-4 AND GF-98 LICENSING IS NOT REQUIRED BUT WILL BE ACCEPTABLE TO PERFORM THIS JOB.

QUESTION 6 Where does Bid Item 6 Temporary Soil Stabilant go?

ANSWER 6

BID ITEM 6 TEMPORARY SOIL STABILANT MAY BE TAKEN TO THE NORTHEAST CORNER OF THE PUBLIC WORKS YARD AREA (NEAR PECAN DRIVE).

QUESTION 7 What is required for Bid Item 7 NPDES Permitting and Maintenance? Is this a SWPPP?

ANSWER 7 SWPP WILL WORK AS LONG AS IT FALLS UDER THE GUIDELINES OF NPDES

SWPPP: REQUIRED BY THE FEDERAL CLEAN WATER ACT, IT OUTLINES MEASURES TO PREVENT STORMWATER POLLUTION.

NPDES (National Pollutant Discharge Elimination System): A PERMIT REQUIRED FOR FACILITIES THAT DISCHARGE POLLUTANTS DIRECTLY INTO A WATER OF THE UNITED STATES (WOTUS)

QUESTION 8

What Traffic Control is required (Bid Item 8)? Is a Traffic Control Plan required to be submitted? If so, will it need to be stamped by a New Mexico Licensed Engineer?

ANSWER 8

NO TRAFFIC CONTROL PLAN IS REQUIRED TO BE SUBMITTED OR STAMPED BY AN ENGINEER; THIS IS FOR PERCAUTION ON MOVING EQUIPMENT COMING OUT OF

WORK AREAS ONTO MAIN STREETS. CAUTION SIGNS LETTING TRAFFIC KNOW THAT MOVING TRUCKS/EQUIPMENT ARE ENTERING AND LEAVING

QUESTION 9

How will excavation be measured for payment (Bid Item 2)?

ANSWER 9

UNCLASSIFIED EXCAVATION (BID ITEM 2) WILL BE MEASURED ACCCORDING TO NMDOT STANDARD SPECIFICATIONS ITEM NUMBER 203000

QUESTION 10

At the pre-bid meeting, it was discussed that the excavated material from both basins can be placed at the northeast corner of the Public Works Yard area (near Pecan Drive). Is this confirmed? Is the use of this area at the contractor's discretion?

ANSWER 10

SEDIMENT MATERIAL CAN BE STOCKPILED AT THE NORTHSIDE OF THE EAST BASIN AREA OR HAULED ELSEWHERE AT CONTRACTORS' DISCRETION

QUESTION 11

Is there a determined allowance amount for Bid Item 5 Removal of Structures and Obstructions to enter into the Bid Schedule?

ANSWER 11

THE ALLOWANCE FOR REMOVAL OF STRUCTURES AND OBSTRUCTIONS WILL BE BASED ON A DAY-BY-DAY AMOUNT, THERE SHOULDN'T BE ANYTHING TO BE REMOVED, BUT IS ON HERE JUST IN CASE THE CONTRACTOR FINDS A STRUCTURE/ OBSTRUCTION DURING THE PROCESS OF THE JOB.

QUESTION 12

Plan Sheet 12 – the Public Works Basin Grading Table shows all points with elevation 4250.00. Please clarify.

ANSWER 12

THE TABLE WAS INCORRECT. PLEASE SEE ATTACHED SHEET, THE CONTOUR LINES AND EVERYTHING ELSE ON THE PAGE WILL REMAIN CORRECT.

QUESTION 13

Does Bid Item 4 Structural Concrete Class A include payment for the Grade Dome shown on plan sheet 14?

ANSWER 13 YES, BID ITEM 4 STRUCTURAL CONCRETE CLASS A, DOES INCLUDE GRADE DOME THAT IS SHOW ON PLANS, SHEET 14
