**Addendum 01

IFB 23-B0009
Withers Swash Dog Park**

The purpose of this Addendum 01 to IFB 23-B0009 for Withers Swash Dog Park, dated August 22, 2022, is to list the key points of discussion from the mandatory site visit.

- All residential streets (Withers Swash Drive, Collins Street) will have a 25-foot setback. All commercial streets (Third Avenue South) will have a 15-foot setback. There will be a 10-foot setback from the cemetery fence in the small dog park area. There will be an 8-foot setback from the bridge. There will be no setback along the path.
- The drive-through gates (1 in each dog park area) will be roll gates. Each dog park area will also have a 20' x 20' "airlock" gate.
- Contractor will be responsible for calling the line locator (811.) The City will be responsible to address City utilities.
- This project is for fencing only. No dog park amenities are requested.
- Bonds will be required for this project. The Contractor will be responsible to pull a permit, but the permit fee will be waived.
- Additional questions are due no later than 12:00 noon on Wednesday, September 7, 2022. Questions may be submitted via e-mail to asowers@cityofmyrtlebeach.com All questions received by the deadline will be answered via addendum.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Wednesday, September 14, 2022. No electronic submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.
