To All Planholders and/or Prospective Bidders:

The following changes, additions, and/or deletions are hereby made a part of the Contract Documents for the construction of **Friar's Branch – South Chickamauga Creek 5 Interceptor Rehabilitation** as fully and completely as if the same were fully set forth therein:

- A. The Pre-Bid Conference Agenda and discussion items are attached.
- B. The Pre-Bid Conference attendance list is attached.
- C. Davis-Bacon Act Labor Compliance items presented by Gina Ogle, Administrative Assistant with Southeast Tennessee Development District, are attached.
- D. Clarifications based on topics raised during the Pre-Bid conference:
 - 1. The method of anchoring bypass pipes to the creek bottom at necessary creek crossings is not stipulated in the contract documents. The Contractor will be responsible for determining the method of anchoring.
 - 2. Regarding General Note 18 on sheet C-004, no additional information is provided regarding the term *recreational users*. Refer also to the Department of the Army Nationwide Permit #3 2017 Nationwide Permit General Conditions requirements for *Navigation*.
 - 3. Regarding the requirements of Specification Section 01 51 43 Article 1.02, that bypass pumping Specialty Contractors shall provide 5 references of projects of a *similar size*, refer to the peak flow rates indicated in paragraph 2.01A of this specification. Reference projects shall be of a size similar to the required peak flow rates.

E. Specification Section 33 01 30.73 Article 1.04 Paragraph A.2 shall be replaced in its entirety with the paragraph below.

The Contractor shall furnish the proposed liner thickness for each pipe segment based on the parameters in Article 2.04 using Enhanced Polyester. If the Contractor intends to use Standard Polyester, the proposed liner thickness for each pipe segment shall also be submitted. Include with this submission a certification, signed and sealed by an engineer registered in the state that the Project is located, to the effect that the proposed liner thicknesses were calculated based on the parameters specified in Article 2.04 of this section of the Specifications and the site specific external loads. In no case will the proposed liner thicknesses be less than those specified in Article 2.04 of this section of the Specifications. The Standard Dimension Ratio (SDR) is the ratio of the outside diameter (OD) of the pipe to its minimum wall thickness. All CIPP wall thicknesses, SDRs by diameters, and depth ranges corresponding to the requirements of the Contract Documents, must be submitted to the Engineer for approval prior to installation.

F. Specification Section 01 22 00 Article 1.08 Paragraph A shall be replaced in its entirety with the paragraph below.

Payment will be made at the unit price bid for each diameter and CIPP thickness, as determined by the proposed liner thickness submittals, required by Section 33 01 30.73, using enhanced polyester. Contractor is not entitled to additional compensation for thicker liners based on the use of Standard Polyester. Contractor is not entitled to additional compensation for thicker liners installed in pipe segments, as compared to the proposed liner thickness submittals required by Section 33 01 30.73. Quantities shall be determined from field measurements verified in writing by the Engineer. Post inspection videos conforming to Section 33 01 30.73 of these Specifications shall be submitted to and reviewed and approved by the Engineer prior to application for payment of the completed CIPP.

All Bidders shall acknowledge receipt and acceptance of this Addendum No. 1 in the Bid Form or by submitting the Addendum with the bid package. Bid Forms submitted without acknowledgment or without this Addendum will be considered in nonconformance.
