This amendment is answer questions received:

- 1- Are the auditorium doors to remain fire rated as currently installed?

The auditorium doors are going to be hollow metal doors, those are all fire rated.

- 2- During the site visit at SFES, it was said that the brick mold was not going to be in the new scope of work, Amendment #1 shows brick mold to be replaced. Will the contractor be responsible for replacement of the brick mold?

Brick mold is going to be replaced by the contractors by PVC.

- 3- What is the rough opening size for each opening being replaced at each school. Are they standard opening sizes or are some under/oversized. I have listed the standard opening size next to each different opening type below.

Fort Mill High School

- 12 Sets of Exterior Doors (6'0 x 7'0?)
- 6 Auditorium/ Girls Locker (3'0 x 7'0?)
- 2 Girls Gym Restrooms (3'0 x 7'0?)

Nation Ford High School

- 1 Interior Door (6'0 x 7'0?)

Springfield Elementary School

- 8 Exterior Doors (3' x 7'0?)

The doors vary, some will be custom and require glass casing/panes as well as the actual door be installed.

- 4- Are they any photos available of any of these openings?

There are three campuses that are within this scope. All doors are different, currently we do not have pictures of each.
