IN THE MATTER OF AWARDING BIDS FOR CONTRACTED SERVICES

WHEREAS, a Public Notice to Bidders asking for sealed bids for Culvert Materials: Galvanized and/or polypropylene; Bituminous Plant Mix Materials; Sign Materials; Bituminous Materials; Concrete Materials; Aggregate/Cinder Materials; Equipment Rental; and Propane was published in the September 22, 2023 edition of the Washington Missourian for receipt by October 13, 2023; and

WHEREAS, a Public Notice to Bidders asking for sealed bids for Fuel; Lubricants; Cutting Blades; Heavy Duty Equipment; and Auto Fleet Maintenance and Repair was published in the September 29, 2023 edition of the Washington Missourian for receipt by October 24, 2023; and

WHEREAS, a Public Notice to Bidders asking for sealed bids for Pavement Marking was published in the October 27, 2023 edition of the Washington Missourian for receipt by November 14, 2023; and

WHEREAS, a Public Notice to Bidders asking for sealed bids for Tires was published in the November 08, 2023 edition of the Washington Missourian for receipt by November 29, 2023; and

WHEREAS, due to Franklin County's ever-fluctuating needs for contractual services, it is imperative that Franklin County have the option to utilize alternate providers in the event that a provider is unavailable to perform required services when necessary; and

IT IS THEREFORE ORDERED by the Franklin County Commission that the Bids for Contracted Services be and are hereby awarded to the Bidders as hereinbefore set forth and as shown in "Exhibit A" for a one-year term, effective January 01, 2024 through December 31, 2024, with the option to renew for three additional one-year terms.

IT IS FURTHER ORDERED in the event an approved vendor is unable to supply the necessary equipment, procurements shall be made with such competition as is practicable under the circumstances.

IT IS FURTHER ORDERED that the County shall, and the officials, agents and employees of the County are hereby authorized and directed to, take such further action, and execute and deliver such documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Order, for and on behalf of the County of Franklin, Missouri.

IT IS FURTHER ORDERED that a copy of this Order be provided to all Franklin County Elected Officials and Department Heads.
