### ADDENDUM No. 1

To all potential bidders of the Commercial Lawn Care Services Bid:

**Question 1: What is the final day to pick up bid packages?**

Final day to pick up bid packages was Tuesday, March 21, 2017 – same day as the last mandatory pre-bid conference.

**Question 2: Regarding Group 10 Bid Form, is the new property (40 acres) at South Terrebonne High School included in the bid package?**

The new property referenced is included in the bid package. TPSD reserves the right to add or remove properties for lawn services as needed. Currently, this acreage is not cut by the TPSD lawn care vendor, but some or all could be maintained by the lawn care vendor in the future.

**Question 3: Is a current Louisiana Contractors License required?**

For this type of contract, no Louisiana Contractors License is required; also, no license number is required on the envelopes of this bid.

**Question 4: A Commercial Pesticide License is required to bid on this contract. Is a 7-D license required?**

7-D license is no longer required. Successful bidders will not be given a contract unless they are licensed commercial pesticide applicators.

**Question 5: This is a 5-year contract. Bond companies are reluctant to issue bonds for longer than 1 or 2 years. How will this be handled?**

No bond is required for this bid other than the \$500.00 surety on Page 1.

**Question 6: The asterisked paragraph, first sentence, at top of Page 22 of bid package referencing alternate areas listed on Pages 19 and 20 appears to be incorrect.**

It is incorrect. It should read: *The alternate areas listed in ANY GROUP on pages 20 and 21 above shall be deducted from the per cut billing should TPSD staff choose to cut these areas.*

Question 7: Will vendors be sent a list of all potential bidders?

The list of all pre-qualified bidders is attached.

Question 8: Will the deadline of March 17 for required site visits be extended?

The deadline for required site visits is extended to April 5, 2017 at 2:00 p.m.

Please return these signed forms/school listings prior to this time and date.

Question 9: Is the additional acreage for Mulberry Elementary shown on the Page 64 aerial photo?

A revised aerial photo showing additional acreage for Mulberry Elementary is attached to replace Page 64.

Question 10: Does the Lawn Care Services Contract allow vendors to subcontract lawn services to other companies?

No part of this contract shall be conducted by a subcontractor without prior written approval from the TPSD Plant Operations/Maintenance Manager and the Terrebonne Parish School Board. Subcontractors will not be allowed unless they meet or exceed the insurance requirements of TPSD.



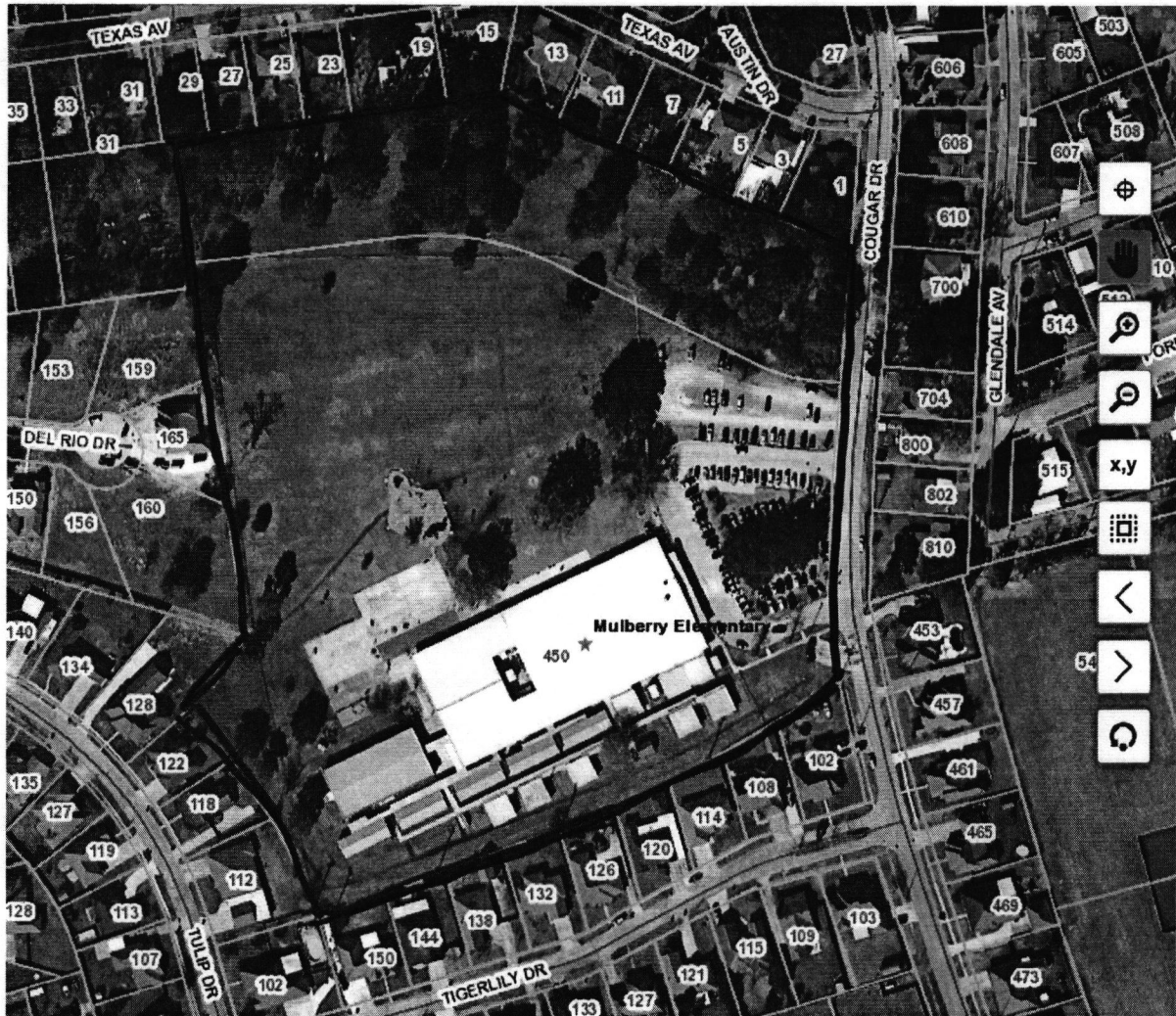
