### **Bid Summary Form:**

The bid summary form has been updated to address comments and questions that were expressed at the pre-bid meeting and to correct the description of some pay items. The updated bid summary attached to this addendum.

**Plans Revisions:**

The following plan sheets have been revised: C-1, C-2, C-3, C-5, C-5A, C-5B, C-5C and C-5D.

The revised plan sheets are posted at the link provided to those who submitted a Bid Document Request form and is titled "Addendum No 1 - revised plans.pdf".

**Questions:**

**Question #1:** Will the City permit any road closures for this work?

Response: Yes, the Contractor will be permitted to close the affected portions of Dixie Street and Langford Avenue for the construction of the project improvements.

**Question #2:** How will the contractor be compensated to repair the street print in the crosswalks on Waterfront Drive?

Response: This question refers to the proposed curb line at the intersections of Waterfront Drive with Dixie and Empire Streets. The contractor will be expected to saw cut a clean edge in the asphalt at the lip of the proposed curb & gutter and pour the gutter against this saw cut edge.

Pay item 39.1, Street Print Repair has been added to the bid summary to be paid per square foot and shall be used at the discretion of the Engineer. The product used for the existing crosswalk is Traffic Patterns XD, Tile Pattern, Heritage Red and White.

**Question #3:** Are there any restrictions associated with soils on-site?

Response: All excavated materials shall remain on-site. Spoils that are suitable material can be placed within the undeveloped rights-of-way for Claude or Barber Streets between Langford Avenue and Waterfront Drive.
