
Addendum #1 is being issued to reflect changes in the specifications, project drawings, and price sheet primarily due to the addition of gates at two other locations along East Fern Avenue.

The following revised items are included in Addendum 1:

- 1) **Specifications** These revised specifications replace the original specifications located on page 4 of the bid packet.
- Dwg-SK-1 and Dwg-SK-2 These revised drawings replace the original drawing Dwg-SK-1 located on page 8 of the bid packet.
- Detail-01 This revised drawing replaces the original Detail-01 sheet located on page 9 of the bid packet
- 4) **Plan Quantity Price Sheet** Updated to reflect a change in estimated quantities and removal of price sheet item #6. This revised price sheet replaces the original price sheet found on page 10 of the bid packet.

Please include all Addendum 1 documents with your bid packet and acknowledge receipt of Addendum #1 on page 3 of the original bid packet.







East Fern Avenue Fence Project Addendum 1 July 29, 2020

REVISED SPECIFICATIONS:

- 1) Contractor to provide all labor, materials, equipment and supervision required for this project as describe within this scope and quantity list and as shown on Dwg-SK-1, Dwg-SK-2 & Detail-1.
- 2) Contractor is responsible for providing a safe worksite and provide any safety items necessary for this work.
- 3) Contractor is responsible for underground locate request. Any utility conflict shall be brought to City's attention immediately.
- 4) Contractor is responsible for layout work.
- 5) Workmanship is to meet industry standard for this type of work.
- 6) Each gate installation consist of two 16 ft. gates. There are three locations of gates for this project. Install the post to a required depth of 5 ft. Install additional wood post with horizontal lumber and steel guy wire cables as required to support the gates and insure satisfactory operation of gates.
- 7) The contractor is responsible for measuring and estimating quantities for new fence and gates installations prior to submitting bid. The quantities shown on the Plan Quantity sheet are estimates only. This is a LUMP SUM job. There will be no pay item for additional wire, steel post wood post or labor and equipment required to complete fence work as shown on drawings and described within this scope.
- 8) The new barbed wire fence is to match the existing 5 strand barbed wire fence along N. Juniper St. at tie in point.
- 9) Contractor is responsible for removing all construction debris from jobsite.
