South Peach Park Walking Trails Addition

PURPOSE: The purpose of this addendum is to address written questions, modify the project specifications, and change Bid Form (Page 1).

#### **ADDENDUM 1:**

#### **Address Questions:**

1. **Question:** Please clarify Bid Alternates 1 & 2. Are these quantities in addition to the work shown in Line 7 or do they substitute for the quantity in Line 7? What is the difference between Line 7 and Alternate Bid #2?

**Answer:** Alternates 1 and 2 will substitute line item #7. The intent is to compare the prices of different ways of constructing the paths. The preferred construction method is sidewalks 5 ft. wide using concrete. Alternate No. 1 is an alternate price for 4 ft. wide sidewalks using concrete. Alternate No. 2 is an alternate price for 5 ft. wide sidewalks using asphalt.

2. Question: What if any are the liquidated damages for this project?

**Answer:** Completion of work is critical for this project due to a fixed deadline of the grant funding a large portion of the project. See the "Failure to Complete Work" addition to the specifications in this addendum.

3. **Question:** Wording on Page 10 (Bid Form Page one) seems a little confusing. It states for the installation of a centerline and edge stripping. Does it need to be reworded to fit the description for the sidewalk.

**Answer:** Paragraph 2 on is incorrect. Attached to this RFB is a new Bid Form (Page 1) that shall be submitted with bid responses in place of the Bid Form (Page 1) published in RFB 18-035.

4. **Question:** Can a full size set of plans be obtained from the engineer, if so please furnish a contact person and phone number.

5.0 FAILURE TO COMPLETE WORK:

- 5.1 Failure to complete the work in accordance with the specifications, shall result in the following:
  - 5.1.1 If the Project is incomplete due to elements beyond the Contractor's control, the amount of payment to the Contractor will be determined by the actual work performed.
  - 5.1.2 If the Contractor fails to complete all work within 60 calendar days plus Inclimate weather days from the date of the Notice to Proceed (NTP) or as specified by written agreement or change order, liquidated damages in the amount of two hundred dollars (\$200) per day will be assessed and deducted from the amount paid to the contractor.
