Clarifications:

Any Task Order issued under RFP 2024-001 that exceeds \$60,000 will be subject to State Wage Determination.

Preproposal Meeting Questions and Discussions:

Local preference for area businesses shall be subject to the requirements shown in Section IV.B on Page 14 of 25.

Proposal submittal requirements shall be in accordance with Section III.B: six (6) hard copies and one (1) electronic copy. Electronic copies shall provided on a USB flash drive.

Each respective item presented in the unit price schedule should be divided into small work and larger work designations to assist Contractor's with accurately pricing the work. An updated Unit Price Schedule has been included with this addendum.

Will a task order be issued for individual patches? It is anticipated that most task orders will include an area containing multiple patches.

All other provisions of the Contract Documents shall remain unchanged. This addendum is hereby made part of the Contract Documents. Each bidder shall acknowledge receipt of this Addendum Number Four (4) using the attached acknowledgment page and submit with each copy of the proposal (not included in page count).
