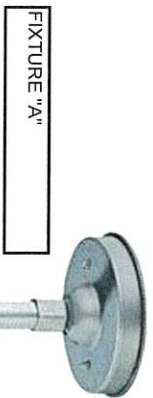

IN E26 LIGHT BULBS

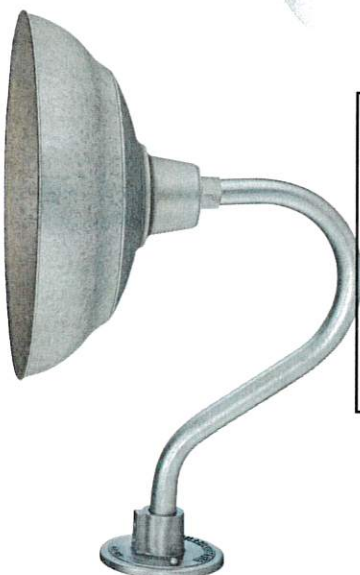
