ADDENDUM 3 TO ITB 18-010

The purpose of this Addendum is to notify potential bidders of a change in the Bid Submission deadline, to provide responses to the questions that were received during the Request for Information (RFI) period, and to provide a revised Bid Form. This Addendum should be acknowledged on your Bid Form.

Bid Submission Deadline

The Bid Submission deadline is changed as follows to allow potential bidders adequate time to respond to this solicitation taking the information from the RFI questions into consideration:

FROM: Monday, November 20th, 2017 at 3:00 pm

TO: Monday, November 27th, 2017 at 3:00 pm

Submission location remains unchanged.

BIDS MUST BE DELIVERED to the Purchasing Division, 600 S. Commerce Ave, Sebring, FI 33870 so as to reach that office no later than 3:00 pm on Monday, November 27th, 2017, at which time they will be opened.

RFI Questions and Responses

The following questions were received from registered vendors before the Request for Information deadline for questions related to this ITB. Answers are provided below each question.

Figures 2 and 3 depict a confining layer between a lower limestone stratigraphic unit and a surficial sand unit with the screened monitored interval installed in the lower limestone unit. The specifications indicate the ten monitoring wells are to be installed in the shallow and deep surficial aquifer. Please clarify the stratigraphy (sand unit, confining unit, limestone unit) and limits of the surficial aquifer that the wells are expected to penetrate and monitor.
 Answer:

The surficial aquifer is believed to be about 200 feet thick in the vicinity of Lake Jackson. Figures 2 and 3 were generalized and a confining unit, nor limestone is not anticipated at the desired depths.

 Figures 2 and 3 depict the well's bentonite seal associated with the contact between the limestone and overlying confining layer. In the absence of a confining unit bidder would expect a bentonite seal to be installed between the well's screened section sand pack and the overlying grouted section. Please confirm the desired/intended location of the bentonite seal.
 Answer:

Since there will be no confining unit, you are correct in saying "bentonite seal to be installed between the well's screened section sand pack and the overlying grouted section".

- Can the bid due date be extended to allow more time to prepare a responsive bid?
 Answer:
 Addendum 2 was issued on October 31, 2017 which extended the bid due date to 3 pm, Monday, November 20th.
- 4) The specifications require that the surface water monitoring stations be installed by a licensed marine contractor. Can the requirement for a marine contractor be waived?
 Answer:
 Yes, per the guidelines in the General Terms and Conditions (Section 00250), Paragraph I.
- 5) Has all permitting required for the installation of the wells and various equipment been completed? If not, will the required permitting a part of the successful bidders contract? (It is understood that a well installation permit (SWFWMD) is required to be obtained by the well installation contractor; are other permits required)? Answer:

Required permitting, other than well installation permitting, will be completed prior to start of installation of this monitoring equipment, and is not included in this contract.

6) The specifications require that the various monitoring equipment be installed by technicians certified by the equipment manufacturer. During a review of the manufacturer's web site, we were unable find a certification program offered by the manufacturer. Is it acceptable for the bidders to install instrumentation in accordance with the manufacturer's installation guidelines without certification?

Answer: Yes

7) What is the anticipated bid award date?

Answer:

Per Instruction to Bidders, Section 00100, paragraph 19.07, "Within thirty-five business days after bid opening, unless otherwise stated in this ITB, Owner will accept one of the Bids or will act in accordance with these Instructions to Bidders or the Section 00250 General Terms and Conditions for Construction Projects". It is anticipated that the bid award date will be sooner than the 35 days specified in the ITB.

8) What is the required start date for this work?Answer:

January 2, 2018, depending on contract (section 00500) approval by the BCC.

9) Is the Marine Contractor requirement going to be omitted as discussed in the Pre-Bid Meeting? Answer:

10) Is The County going to take care of the surveying to save money as discussed in the Pre-Bid Meeting? It is my understanding that the County would like us to provide quotes for Surveying but will probably take care of that themselves.

Answer:

See the Bid Form (section 00300, paragraph E, Pricing), surveying services are a mandatory deductive alternative bid item.

11) Is The County going to omit "As Built" drawings and substitute that with Photo Documentation as discussed in the Pre-Bid Meeting?

Answer:

For wells, field well construction diagrams (sketches) as required by SWFWMD or FDEP permits are required and should be submitted as a part of the permit requirement, and to the County Geologist. For surface water monitoring systems, the Contractor should develop record drawings with detailed information for submittal to the County. At the end of the project the County will use the record drawings to develop accurate as-built drawings. In addition, the contractor should provide photo documentation

- 12) Surface Water Monitoring Stations: It is my understanding that the County wants us to bid the Surface Water Monitoring Platforms as being 20 foot in length per discussions in the Pre-Bid Meeting. Is this correct?
 Answer:
 Yes
- 13) Groundwater Monitoring Stations: It is my understanding that The County does not know the exact depth the wells are to be dug and will accept a bid from the well drillers as Cost per foot. It is also my understanding that the County's geologist will accompany the Well Drillers to determine completion depth, etc. If The County wants a bottom line number on the bid, do you want us to bid based on "Summary of Work" (1.02 Table 1) Well 1 (50'), Well 2 (150'), Well 3 (1 @ 30' and 1 @ 150'), Well 4 (1 @ 50'), Well 5 (1 @ 100'), Well 6 (1 @ 50' & 1 @ 150'), Well 7 (1 @ 30' & 1 @ 150')? The Cost/ft' would be added to or subtracted from the bid base price accordingly. Would that be acceptable?

Answer:

See the revised Bid Form (Section 00300) included with this addendum. The revised bid form changes section E to address this question.

14) Can you clarify what sites get instrumented? It is my understanding that the Weather Station (1), All Surface Water Monitoring Stations (3), and some of the Groundwater Monitoring Stations (?).

Answer:

The groundwater stations to be instrumented are at sites #3, #6 and #7. The instrumentation includes a pressure transducer per well, and a data logger and solar panel for power to the logger per site.

- 15) It is my understanding that once the equipment is installed, that the County will be responsible for all maintenance & data collection at the stations, including surface water stream gauging (manual flow measurements & and station rating). Is this correct?
 Answer:
 This is correct.
- 16) It is also my understanding that none of the equipment requires telemetry. Is this correct?Answer:This is correct.

- 2. Bidder has visited the Site and become familiar with and is satisfied as to the general, local, and Site conditions that may affect cost, progress, performance, and furnishing of the Work;
