ADDENDUM TO ITB 18-010

WHEREAS, on October 1, 2017 and October 8, 2017, HIGHLANDS COUNTY advertised an Invitation to Bid for the Lake Jackson Watershed Hydrology Groundwater, Meteorology and Surface Water/Stream Flow Sensor Acquisition and Installation project ("ITB 18-010");

WHEREAS, the advertisement for ITB 18-010 was published in the Highlands News-Sun newspaper, and posted on the Highlands County Board of County Commissioners website and the Highlands County Public Notice Bulletin Board;

WHEREAS, the Highlands News-Sun, the Highlands County Board of County Commissioners website, the Highlands County Public Notice Bulletin Board, and ITB 18-010, page 4, stated that a Mandatory Pre-bid Meeting would be held on Wednesday, October 11, 2017, at 2:30 p.m., in the County Engineering Training Room, 505 S. Commerce Avenue, Sebring, Florida 33870; however, page 10 of ITB 18-010, incorrectly stated that a Mandatory Pre-bid Meeting would be held at 2:00 p.m., Thursday, October 12, 2017, in the Engineering Training Room, Sebring, Florida 33870;

WHEREAS, bidders appeared to attend the Mandatory Pre-bid Meeting on October 11, 2017, at 2:30 p.m., and on Thursday, October 12, 2017, at 2:00 p.m.;

WHEREAS, Wednesday, October 11, 2017, at 2:30 p.m., was the correct date for the Mandatory Pre-bid Meeting and the Pre-bid Meeting was held on that date, and Thursday, October 12, 2017, was the incorrect date for the Mandatory Pre-bid Meeting and, therefore, the Mandatory Pre-bid Meeting was not held on Thursday, October 12, 2017;

WHEREAS, any bidder who appeared on Thursday, October 12, 2017, was unable to participate in the Mandatory Pre-bid Meeting;

NOW THEREFORE, to provide an opportunity for attendance at a Mandatory Pre-bid Meeting for ITB 18-010 for any bidder who appeared on October 12, 2017, this Addendum serves as public notice of the advertisement of a second Mandatory Pre-bid Meeting for ITB 18-010, which shall occur as follows:
