Allowance No. 8: Lump Sum Cash Allowance: Include the sum of: [\$1,201,129.00] One Million Two Hundred One Thousand One Hundred Twenty Nine Dollars and Zero Cents for purchase and delivery of Trane HVAC equipment as specified in Section 23 8114 Rooftop Dx Unit, Section 23 3616 Variable / Constant Volume Air Terminals, Section 23 8126 Ductless Split Unit, Gas Rooftop Units (RTU) Schedule On Drawing M001, Ductless Split Schedule Shown On Drawing M-001, Volume Box Schedule (VVB) Shown On Drawing M-002. This allowance also includes Trane controls equipment and labor as shown in HVAC Controls Drawings M401, M402, M403 and specified in Section 23 0923 Building Systems Controls.
 - 1. This allowance includes the material costs and freight from Trane but does not include receiving, handling, and Contractor mark-up and profit.
 - 2. [\$473,000.00] Four Hundred Seventy Three Thousand Dollars and Zero Cents of the total Trane HVAC Equipment Allowance is for controls labor subcontract not subject to sales taxes and is Non-Taxable. The remaining [\$728,129.00] Seven Hundred Twenty Eight Thousand One Hundred Twenty Nine Dollars and Zero Cents is subject to Sales Tax.
 - 3. Sales Tax is not included in the Trane HVAC Equipment Allowance and is to be calculated by the Contactor and included in the Base Bid cost.




