As a result of inquiries, the following clarifications/changes are provided for your information. Please make all appropriate changes to your quote documents. Note: changes are reflected with original language shown with strike-through and new language is underlined.

Q1: Does the scope include replacing the stringers underneath the deck boards of the bridge as well, or just the decking alone?

A1: Yes, the work includes replacing the timber stringers.

Q2: It says the Owner will provide the lumber and all wood for this project, will the Owner also provide hardware or is that on the GC?

A2: The owner is also providing the lag screws, washers and silicone in addition to the support timbers and timber decking – see Statement of Work, District Responsibility.

Q3: Is the Owner responsible for hauling the demoed material or does that fall on the GC?

A3: The GC is responsible for disposing of all demo'd material.
