Painting at Crabtree Memorial Gymnasium**

The purpose of this Addendum 01 to IFB 23-B0003 for Painting at Crabtree Memorial Gymnasium, dated July 11, 2022, is to list the key points of discussion from the mandatory site visit.

- All colors will be selected by building staff, and must be approved before any work may begin.
- Any brand of paint designed for exterior use that is readily available in the commercial market (ex: Sherwin-Williams, Valspar, Behr, etc) is acceptable, provided that the colors match what is selected by City staff.
- The City will be responsible to remove/trim all plants that would interfere with painting.
- Building is to be pressure-washed before any painting work begins.
- Contractor is responsible to remove any rust/corrosion before applying paint.
- Areas to be painted include, but are not limited to: walls, overhangs, doors, gutters/downspouts, window frames, and columns.
- The mural is to be repainted in its current design, with colors approved by City staff.
- Windows are to have existing caulk cut out and then be re-caulked.
- Louvres should be removed to be painted. Any spray painting should be done off-site.
- The City will be responsible for stucco repairs prior to painting.
- The following items will **NOT** be painted: tiles on the parking lot side of the building, storefront window or doors at the main entrance to the building, flagpoles.
- A lift will be able to access all areas of the building. Parking spaces can be blocked off in the parking lot.
- Additional questions are due no later than 12:00 noon on Monday, August 1, 2022. Questions may be submitted via e-mail to asowers@cityofmyrtlebeach.com All questions received by the deadline will be answered via addendum.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Monday, August 8, 2022. No electronic submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.
