**Addendum 01

IFB 22-B0036
Thunderbolt Park Renovations**

The purpose of this Addendum 01 to IFB 22-B0036 for Thunderbolt Park Renovations, dated March 29, 2022, is to list the key points of discussion from the mandatory pre-bid site visit.

- The L-shaped counter will have a swing door. Recommended framing is 2x4 white pine, but the Contractor is free to select other material for framing. Rough-cut lumber will be required to achieve an “old” look.
- The office area recommended framing is 2x4 white pine, but the Contractor is free to select other material for framing. Rough-cut lumber will be required to achieve an “old” look.
- Drywall will be painted with Spectrum lavender wisp paint. Sherwin-Williams may be able to match the color. Paint is to be latex and not oil-base.
- Welding fence with 2” x 4” squares to be installed on the top of the wall to protect HVAC equipment and wildlife displays. Fencing to have 4-inch posts spaced 4-feet apart.
- The wall with two (2) windows are to be spaced evenly apart, and centered around the solid beam. All windows to have an aluminum frame, bronze in color, to match the existing work on the outside of the building.
- Contractor is NOT to start demolition until all windows are in-hand and ready to be installed.
- Contractor is responsible for all inspections.
- Additional questions are due no later than 12:00noon (local time) on Thursday, April 14, 2022. Questions may be submitted via e-mail to asowers@cityofmyrtlebeach.com All questions received by the deadline will be answered via addendum.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Thursday, April 21, 2022. No electronic submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.
- The mandatory pre-bid site visit sign-in sheet is attached and is hereby made part of this addendum.
