Subject: Asphalt Concrete Resurfacing and Soil-Cement Reclamation

The following **2 modifications** shall be included in the bid submittal for the referenced ITB;

In ITB Section entitled "Bidding Instructions"; sub-section "Information Instructions", shall be **modified** as follows:

The purpose of this solicitation is to enter into a unit price contract with one firm to be the primary supplier of the 2018 LMIG & 2019 TSPLOST Asphaltic Resurfacing and Soil-Cement Reclamation Project.

No specification expressed or implied shall be construed as any type of restrictive specification that would limit competition.

Unless clearly shown as "no substitute" or any words to that effect, any items in these contract documents which have been identified, described or referenced by a brand name or trade name are for reference only. Such identification is intended to be descriptive, but not restrictive and is to indicate the general quality and characteristics of products that may be offered. Each bid item for which an equivalent item is proposed must be individually identified on the bid sheet with the following information: brand name, model or manufacturer's number or identification regularly used in the trade. The County shall be the sole judge of the suitability of the proposed alternative and may consider function, design, materials, construction, workmanship, finishes, operating features, overall quality, local service facilities, warranty terms and service or other relevant features.

The County reserves the right to cancel the contract at any time with 30 days written notice.

Title to any supplies, materials, equipment or other personal property shall remain the Contractors' until fully paid for by the County.

All items to be bid FOB, Putnam County, Georgia. No sales taxes are to be charged.

Any damage to any building or traffic control device, or equipment incurred during the course of work shall be repaired at the contractor's expense to the complete satisfaction of Putnam County with no additional expense to the County. Unless otherwise approved by the County, the prime contractor shall perform <u>ALL</u> the asphalt resurfacing work. Other bid items can be subcontracted.

Potential bidders shall also be cognizant that the following liquated damages shall be applicable assessed to the prime contractor if any of the following conditions apply:

- Project completion does not occur (with the exception of the punch list items) within 90 calendar days; inclement weather days excluded \$1000 per day liquidated damages
- > Striping and traffic tape after milling and paving; as described in the "Project Descriptions & Work Scope/Specifications" section of the ITB, does not occur \$1000 per day liquidated damages
- ➤ Shoulder reconstruction; as described in the "Project Descriptions & Work Scope/Specifications" section of the ITB, does not occur \$1000 per day liquidated damages

In ITB Section entitled "Project Descriptions & Work Scope/Specifications"; sub-section "Full Depth Reclamation Soil-Cement Base", shall be **modified** as follows:

<u>Full depth cement treated base reclamation</u> work scope shall be utilized on Southshore Road. Given the pavement condition of Southshore Road, the County will require that the full depth reclamation and soilcement base construction work be accomplished as the <u>first project</u> to be undertaken when the contract is signed. Other projects can be constructed simultaneously with Southshore but in no circumstances shall the other projects commence prior to Southshore Road.
