Questions/Answers:

**Question #1:** I am looking over the pricing list, and I noticed that there isn't any SF listed for Riverwalk and Summer Place garages. Is this information available or do we need to measure these ourselves?

<u>Answer #1:</u> Riverwalk Garage has 250,000 SF (estimated) and Summer Place Garage has 216,000 SF.

**Question #2:** I also noticed on the pricing list there was a line item for Regal garage, but that is now State Street, correct?

<u>Answer #2:</u> The Proposal Form has been updated to show State Street Garage (not Regal Garage) which is 451,080 SF. The garage near Regal's Corporate Offices is Riverwalk Garage.

**Question #3:** I was reading through the reclaim requirements and was wondering if you can put me in touch with the right person at storm water. The reason I ask is in all other municipalities we work in we get a special discharge permit for our wastewater we treat on site in our mobile water treatment plant. This allows up to legally discharge right into the sanitary sewer on site. We have received such permits from the City of Charlotte, City of Wilmington, City of Durham, City of Raleigh, and others.

<u>Answer #3:</u> Per their permit, the City of Knoxville, Tennessee cannot allow any product or material into the stormwater system other than stormwater. Knoxville Utilities Board (KUB) manages the sanitary sewer and has a permitting process through their Industrial Pretreatment Program (IPP). The IPP may be contacted at 865.594.8367. The Proposal Form has a separate line for the cost of reclamation services, see item 6.1.40, that will be in addition to the pricing listed on the other lines, if needed.

**Question #4:** For the parking garages, I am aware we can get a permit though the city for a nearby hydrant and get a meter through KUB. However, I wanted to see if this is standard or if you have in insights how we could better serve you and make the water consumption process a little more efficient. Water trucks do not hold near enough to keep work flowing in a timely manner.

<u>Answer #4:</u> PBA managed garages are mainly open 24/7 so we do not have any of them cleaned in their entirety since they're never totally empty. Where pressure washing is requested in the garages, it is localized in stairwells and/or elevator landings. A water tank will be sufficient in these instances.

**Question #5:** On the Sunsphere, at the base how far out is needing to be cleaned as directly around the Sunsphere is not a large area but going to the retaining walls is much more.

<u>Answer #5:</u> There is a colored circle on the concrete that surrounds the Sunsphere and is approximately 30' out from the base. Pressure washing does not go out passed this area.

**Question #6:** At Volunteer Landing the stair tower is in reference to the stairs and platforms going up to the pedestrian bridge correct? And at the base of the stair tower is that area to be cleaned as well or just stairs and platforms?

Answer #6: As the technician washes down the stairs and platforms, the water will naturally drain down to the concrete walkway at the base. This area is to be cleaned as well.
