Response: No. As stated in the original bid document, "The RFQu response must be

complete, clear and concise, not to exceed fifty (50) $8\frac{1}{2}$ " x 11" pages (may be fewer) and numbered at the bottom right hand corner of the page. The

submittal shall use a minimum 12-point Times New Roman font."

Question 2: Could you please clarify what specific legal form(s) should be included in Section B.

Content 1b under cover letter?

Response: This section states the following:

"b) Legal form(s) of company (partnership, corporation, joint venture, etc.). If joint venture, identify the members of the joint venture and provide all information required within this section for each member."

We are simply asking for you to identify the type of company your firm is. Your firm should have and/or will have to submit a W-9 form during the registration process when registering with Georgetown County before you are able to submit your bid so you will not need to provide that form again as part of your RFQu submittal but it should be stated as part of your cover letter.

Question 3: What type of grants will be included in this contract?
