- e. Escrow of Bid Documentation: This must include all required documentation. See document titled Escrow Bid Documentation for more information.
- f. Performance Bond (100%): On the form provided in the Contract Documents and fully executed as indicated on the form.
- g. Payment Bond (Contractor's Labor & Material Bond) (100%): On the form provided in the Contract Documents and fully executed as indicated on the form.
- h. Insurance Certificates and Endorsements as required.
- i. Workers' Compensation Certification.
- j. Prevailing Wage and Related Labor Requirements Certification.
- k. Drug-Free Workplace Certification.

- l. Tobacco-Free Environment Certification.
- m. Hazardous Materials Certification.
- n. Lead-Based Materials Certification.
- o. Imported Materials Certification.
- p. Registered Subcontractors List: Must include Department of Industrial Relations (DIR) registration number of each subcontractor for all tiers.

Failure to comply with these conditions within the time specified will entitle District to consider your bid abandoned, to annul this Notice of Award, and to declare your Bid Security forfeited, as well as any other rights the District may have against the Contractor.

After you comply with those conditions, District will return to you one fully signed counterpart of the Agreement.
