A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, APPROVING THE EVALUATION **COMMITTEE'S** RANKING **AND AUTHORIZING** PURCHASING DIRECTOR TO NEGOTIATE A CONTRACT WITH THE TOP-RANKED PROPOSER, RISK MANAGEMENT ASSOCIATES, INC., **FOR PROPERTY** & **CASUALTY** INSURANCE; PROVIDING FOR EXECUTION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on March 29, 2019, in accordance with the City of Parkland's (City) Procurement Code, City Staff advertised Request for Proposal (RFP # 2019-07) for Property and Casualty Insurance; and

WHEREAS, on April 23, 2019, the City received three (3) proposals from Risk Management Associates, Inc., Florida Leagues of Cities, Inc. and World Risk Management, LLC; and

WHEREAS, on May 2, 2019, the Evaluation Committee reviewed, rated and shortlisted the three (3) proposals for interview; and

WHEREAS, on May 21, 2019, the Evaluation Committee interviewed the shortlisted three (3) proposers and after further discussion and review of the criteria set forth in the RFP, the Evaluation Committee unanimously recommended approval of the top-ranked proposer, Risk Management Associates, Inc.; and

WHEREAS, the proposed estimated annual fee submitted by Risk Management Associates, Inc. to complete the scope of services is \$333,607 which is budgeted in FY2019; and

WHEREAS, the initial contract period shall start on date of contract execution and shall continue for a period of three (3) years, with the option to extend for two (2) additional one (1) year periods, if determined to be in the City's best interest; and

WHEREAS, the Evaluis recommending the Purchasing Director negotiate terms, condition and fees with the top-ranked proposer, Risk Management Associates, Inc., for Property and Casualty Insurance.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA AS FOLLOWS:

<u>Section 1.</u> The foregoing "WHEREAS" clauses are confirmed and ratified as being true and correct and are hereby incorporated herein.

<u>Section 2.</u> The City Commission hereby approves the Evaluation Committee ranking for Property and Casualty Insurance and authorizes the Purchasing Director to negotiate terms, conditions and fees with the top-ranked proposer, Risk Management Associates, Inc., and extend the contract for two, one-year periods, if determined to be in the City's best interest.

Section 3. In the event the Purchasing Director is unable to negotiate a contract deemed to be acceptable with the top-ranked firm, the Purchasing Director shall report to the City Commission which shall either require that the Purchasing Director continue negotiations or

	negotiating; at any time the City Commission has the full discretion to either abandon the
