Question:

I was unable to find if we are able to hook into residents' water or if we need to bring our own. It gets significantly more expensive if we can't hook to a faucet at the homes. If we couldn't use their water is there a possibility of getting permission to hook to a hydrant to fill? If not, we can accommodate, but again, it's more expensive.

Answer:

The awarded vendor will be permitted to hook into the residents' water supply for use during the cleanings. An updated voucher is attached below indicates that this, so that the homeowners are aware. It states that water will be provided by the resident/landlord.

Question:

Most homes cost different amounts based on square footage or type of stains that we're removing. It would be difficult to give a price per home. Would a price per square foot be an acceptable form of quote to accommodate the price differences per home? Or do you need a certain price per home?

It is suggested that interested vendors drive through the neighborhood so they know the square footages of the residences to provide a proper "average" per house cost.
