The following changes are to be incorporated into the solicitation documents dated **March 7, 2023.** All those receiving this addendum should modify their documents to show the below described changes.

1. Answers to questions submitted prior to the deadline of 5:00 pm on March 27, 2023.

- **Q1:** Attachment B lists the materials to be provided by GDOT. Materials include cabinet (w/internals), signal/pedestrian heads, backplates, hardware, pedestrian poles, wire, pull boxes, and signs. Who is responsible for the strain poles, street name signs, and power service point materials?
- **A1:** The selected vendor will be responsible for providing and installing any items not provided by GDOT.
- **Q2:** Who will supply materials for the signal head replacement scope of work? Please confirm backplates and mounting hardware are to be included.
- **A2:** The selected vendor will provide the materials for the signal head replacement project. Backplates and mounting hardware will need to be provided.
- **Q3:** Who will supply FYA signal heads, backplates, and hardware for alternate pricing? Additional 7-Conductor?
- **A3:** The selected vendor will provide all materials for the alternate.
- **Q4:** The scope of work for signal head replacement at 5 intersections refers to cable. Can you specify just 7-Conductor for signal heads being replaced? Who will supply cable?
- **A4:** The selected vendor will provide the 7 conductor cable to complete the project.

Q5: The strain poles are to be furnished by the Contractor?

A5: Yes, that is correct.

Q6: There are 2 6'x40' loops on the plans but Union Church Rd loop is not called out to be installed. Is the contractor to install (2) 6'x40' loops?

A6: Yes, that is correct.

Q7: There is striping on the plans but is not called out. Is the contractor to install thermo? If so, what is the quantity?

A7: Striping will not be in the contract. It will be installed by the County.

Q8: Attachment C, the signal heads listed are they to be supplied by contractor or GDOT?

A8: The selected vendor will provide signal heads listed in Attachment C.

Q9: Attachment B, GDOT supplied, will contractor pick these up from GDOT district office or Oconee County?

A9: The materials can be picked up from Oconee County. The County will coordinate delivery with GDOT.

Q10: Attachment A, There are no indications on striping (stop bars) is this supplied by contractor or others?

A10: Striping will not be in the contract. It will be installed by the County.

Q11: Contract documents mention LS's of 2500 per day, what is the number of days to complete?

A11: Liquidated Damages will not apply to this project.
