TO ALL POTENTIAL BIDDERS:

The following information is being provided for purposes of clarification or in response to questions received from potential bidders. In the event that any of these specifications conflict with previous specifications, the specifications in this addendum shall control. Prepare your bids accordingly:

- <u>Question</u>: Specification 076200, 2.5, A and following notes to shop fabricate coping and coping miters to profile shown in SMACNA Fig 3-4A using .040 aluminum. Specification 076201 specifies a pre-manufactured fascia system with a lifetime 215mph wind warranty. Detail 1/A-501 shows a fascia detail that matches the 076201 specification section. There is no detail/call-out shown on the parapet/edge of the roof stairwell. Does the shop fabricated coping occur at the stairwell roof? or somewhere else?
 <u>Answer</u>: Detail 1/A-501 applies to all parapet conditions including the stairwell roof.
- 2. <u>Change</u>: Details on fall protection for the skylight have been included in red on the attached Sketch A-1. This cost shall be included as an Additive Bid Item.
- 3. <u>Change</u>: Details on relocation of the stairwell roof drain exit is attached as Sketch A-2. This cost shall be included in Part A on the Bid Form.
- 4. <u>Change</u>: New bid form is attached.

<u>Note:</u> A signed acknowledgement of this addendum must be received by this office prior to the due date and time, or must be attached to your bid. Signature on this addendum does not constitute signature on the original bid document. The original bid document must also be signed per bid instructions.
