BIDS TO BE OPENED: December 1, 2017 ** (see below) at 11:00:00 a.m. (Eastern Time)

This addendum becomes a part of the contract documents and modifies the original specifications as noted.

Item 1. Postponement of Bid Submission Deadline

The deadline for submission of bids is hereby postponed until 11:00:00 a.m. (Eastern Time) on December 6, 2017. The deadline for questions of November 27 remains.

Item 2. Responses to Questions Submitted to the Office of the Purchasing Agent

Question #1: Request a copy of bid tabulations from your last awarded bid for gasoline and diesel.

Answer: See Attachment A.

Question #2: Request a copy of the original awarded vendor's bid from your last awarded bid (pages where they put their pricing and/or signature and any additional pages provided with their bid) for gasoline and diesel.

Answer: See Attachment B.

Question #3: Provide two (2) invoices per month of your current contract delivered by your current vendor(s) and corresponding bill of ladings of gasoline and diesel.

Answer: See Attachment C

Question #4: When is the award date?

Answer: The desired contract start date is February 1, 2018.

Question #5: When is the first board meeting after the opening?

Answer: The first possible Council meeting when the award could be approved is December 19, 2017.

Question #6: Will decision be made before or at the board meeting?

Answer: A recommendation will be submitted to City Council for approval.

Question #7: Will you split the award by tank wagon and transport?

Answer: No. The winning bidder is expected to provide both.

Question #8: What is the average load size for gas and diesel?

Answer: Please see attached invoices for load size.

Question #9: Can or will deliveries be split between locations?

Answer: Yes, state in the comments on the bid form if the bid includes additional costs for split deliveries.

Question #10: Is there a DBE requirement for this bid?

Answer: No

Question #11: Do you by any chance know your annual usage per location?

Answer: See attached invoices for estimated volumes per delivery per location. We place weekly orders of unleaded and diesel for the Hill Avenue, Loraine Street, and 5th Avenue locations.

Question #12: Have you had any deliveries other than clear on road diesel?

Answer: No

Question #13: Do you currently use any of the Bio Diesel?

Answer: No

Question #14: Must we bid on the renewable hydrocarbon diesel to be considered for award?

Answer: The City intends to award the bid to one vendor to provide all fuels.

Question #15: Who is your current vendor?

Answer: JAT Oil

Question #16: Please provide current copies of invoices and bill of ladings for each product.

Answer: See Attachment C for invoices. We do not retain the bill of ladings.

Question #17: How will the renewable be priced? There is not OPIS price for renewable diesel in Knoxville TN.

Answer: Renewable will be priced at a per gallon market rate. Please provide your quoted price per gallon for the renewable as of the date required on the ITB, November 20, 2017.

Question #18: Will renewable diesel be priced off of the ULSD OPIS value for Knoxville TN?

Answer: No, see question #17.

Question #19: Are vendors required to bid on all products?

Answer: Our desire is to award only one contract for all products. A “no bid” for any of the specific commodities required may result in rejection of the bid.

Question #20: On the bid form it states “87 Octane mid-grade”, midgrade gasoline is 89 octane. Does the city wish to receive 87 or 87 octane gasoline?

Answer: The City requires 87 Octane.

Question #21: Which OPIS value will the B1 diesel fuel be priced on? There is no B1 diesel posting in OPIS for Knoxville TN.

Answer: The B1 diesel fuel will be priced on the ULSD OPIS values.

Question #22: Will the B5, B10 and B20 be priced on the respective OPIS values or ULSD OPIS values?

Answer: The B5, B10, and B20 will be priced on the respective values.

Question #23: Will the City only order bio blends in full transport loads? There is not markup option for tankwagon bio blend loads.

Answer: Yes

Question #24: Is the charge for tankwagon to be a charge over the OPIS price?

Answer: Yes, per the bid form, additional cost for tankwagon delivery should be listed as a separate cost from the OPIS price. The OPIS price is to be what OPIS posted on November 20, 2017 with no additional costs included.

Question #25: Is the charge for tankwagon to be a charge over the fixed factor?

Answer: Per the bid form, additional cost for tankwagon delivery should be listed as a separate cost from the fixed factor.

Question #26: Which sites will require tankwagon deliveries?

Answer: See Attachment A – Location of Delivery Sites of the Bid for the two locations requiring tankwagon deliveries.

Question #27: What is the average delivery sizes for transport deliveries?

Answer: See Attachment C for invoices indicating delivery loads.

Question #28: Will the gas tank at 1222 5th Avenue be accessible by a transport truck?

Answer: Yes

Question #29: Will KAT order both gas and diesel for delivery on the same truck to take advantage of full transport pricing?

Answer: Yes

Question #30: Will loads ever be order for delivery to more than one site? If so, how often?

Answer: Possibly. See attached invoices for ordering history.

Question #31: What are you payment terms (Net 10, 15, 30)?

Answer: The City pays fuel invoices upon receipt.

Question #32: What are the payment terms and method? Is it based on Date of Invoice or Date of Delivery?

Answer: The City pays by check immediately upon receipt of invoice per the date of invoice.

Question #33: For location that have more than one tank, are the tanks next to each other?

Answer: Yes

EQUAL BUSINESS OPPORTUNITY PROGRAM

Contracting Component

SECTION I

EQUAL BUSINESS OPPORTUNITY PROGRAM "GOOD FAITH EFFORT PLAN"

The City of Knoxville strongly encourages contractors to employ minority owned businesses and women owned businesses as subcontractors whenever feasible. This is viewed favorably by the City of Knoxville. In fact, the City's goal for minority and women owned business participation is 10 percent of the contract amount.

Prime contractors will consider all competitive sub-bids and quotations received from minority owned businesses (MOB) and women owned businesses (WOB). When a subcontract is not awarded to the MOB/WOB submitting the lowest bid, the prime contractor must document the reason(s) the award was not made in writing. If the Contractor terminates an agreement and/or subcontract with a MOB/WOB, then the contractor is required to strongly consider selection of another MOB or WOB as a replacement.

GOOD FAITH EFFORTS

1. Soliciting through all reasonable and available means:
 - a. Advertising
 - b. Written notices to all certified MOB's and WOB's who have the capability to perform the work or provide the service.
 - c. Solicitation of interest must be within sufficient time to allow MOB's and WOB's to respond to the solicitation.
 - d. Faxes, direct mailings, and telephone requests.
2. Providing interested MOB's and WOB's with adequate information about plans, specifications, and requirements of the contract in a timely manner to assist them in responding to a solicitation.
3. Negotiating in good faith with interested MOB's and WOB's.
 - a. It is the bidder's/proposer's responsibility to make opportunities available to MOB's and WOB's subcontractors and suppliers and to select opportunities consistent with the available MOB/WOB business subcontractors and suppliers. Evidence of such negotiations includes the names, addresses, and telephone numbers of MOB's and WOB's considered.
 - (1) A description of the specifications for the work selection for subcontracting.
 - (2) Evidence why agreements could not be reached for MOB's and WOB's to perform the work.
4. Effectively using the services of available minority, women contractor groups, local minority and women business assistance offices, small business groups, and other organizations on a case-by-case

basis to provide assistance in the recruitment and placement of minority/women business

SECTION II

MOB/WOB SUBMITTAL TIME FRAME

The Contractor will submit the following forms with the **bid/proposal**:

1. "Statement of Intent for MOB/WOB Utilization" (Form I Attached)

This form will be submitted by the bidder/proposer if he/she plans to subcontract any portion(s) of the work with a MOB and/or a WOB. This form illustrates the areas the Contractor has identified as potential MOB and/or WOB subcontract opportunities and the dollar value associated with these opportunities. The purpose of "Form I" is to measure the Contractor's "Good Faith Efforts." It does not commit the prime to subcontracting these areas only to MOB and WOB firms or release the prime from negotiating with MOB/WOB firms for subcontract opportunities.

OR

2. "Statement of Intent of Performing Work Without Subcontracting" (Form II Attached)

This form will be submitted if the bidder/proposer does not plan to subcontract any portion(s) of the work and if there are not any sufficient material purchases in which MOB/WOB firms can be utilized. The bidder/proposer must certify that this has been a typical practice on projects of similar scope and dollar value. By submittal of Form II, the Contractor certifies that:

- (1) He/she does not typically subcontract on projects of similar scope and dollar value
- (2) He/she will not enter into any subcontract for duration of the project, and if he/she does decide to subcontract any portion of the work, he/she will: notify the City immediately of the decision to subcontract and adhere to the provision of "Good Faith Efforts" in filling that subcontract opportunity

The Purchasing Division may request the apparent low bidder/proposer to provide additional information to clarify the bidder's/proposer's responsiveness and intent in this regard.

These documents will be received by the Purchasing Division upon submission of a proposal/bid. Additionally, prime contractors who submit Form I stating their intent to use MOB or WOB subcontractors for any part of the contract are required to report the amount(s) they have paid to these subcontractors on June 30th and December 31st of each year. Failure to submit this reporting data may result in a delay of payments. At the time of the final request for payment, the prime shall submit a Statement of Final Payments to MOB and WOB Subcontractors and Suppliers (Form III attached). Final payment will not be released by the City until Form III is submitted.

SECTION III

DEFINITIONS

Minority: A person who is a citizen or lawful admitted permanent resident of the United States and who is a member of one (1) of the following groups:

- a. Black American, which includes persons having origins in any of the Black racial groups of Africa;
- b. A Hispanic American, which includes persons of Mexican, Puerto Rican, Cuban, Central or South American or other Spanish culture or origin, regardless of race;
- c. Native American, which includes persons who are American Indians or Alaska Native;
- d. An Asian-Indian American, which includes persons whose origins are from Indian, Pakistan or Bangladesh;
- e. An Asian Pacific Islander, which includes persons whose origins are from Japan, China, Taiwan, Korea, Vietnam, Laos, Cambodia, the Philippines, Samoa, Guam, the U. S. Trust Territories of the Pacific and Northern Marianas.

Minority-Owned Business (MOB), Women-Owned Business (WOB): A business which is at least (51%) owned and controlled by minority group members or European American female(s). A MOB/WOB is bonafide only if the minority group interests are real and continuing and not created solely to meet the MOB/WOB requirement. In addition, the MOB/WOB must perform satisfactory work or services to provide supplies under the contract and not act as a mere conduit. In short, the contractual relationship must be bonafide. Certification of minority owned businesses and women owned businesses is provided by City Community Relations Office.

Owned and Controlled: A business which is (1) a sole proprietorship legitimately owned by an individual who is a minority or European American female, (2) a partnership or joint venture controlled by minorities or European American females, and in which at least (51%) of the beneficial ownership interests legitimately are held by minorities or European American females; or (3) a corporation or other entity controlled by minorities or European American females, and in which at least 51% of the voting interests and 51% of the beneficial ownership interests are legitimately held by minorities or European American females. In addition, these persons must control the management and operation of the business on a day-to-day basis.

Subcontractor: Any named person, firm, partnership, or corporation which supplies any work, labor, services, supplies, equipment, materials, or any combination of the foregoing contract with the contractor on a public contract.
