2. QUESTIONS/ANSWERS

1.	Q1 - I received this solicitation to bid for Hamilton County : BID 24-24, SCHOOL CLOTHING, APPAREL, ATHLETIC UNIFORMS, AND ACCESSORIES Is their an actual product list to bid on?
Answer	HCS is seeking a discount off contract with vendor(s) that can provide for purchase and delivery on a variety of school clothing apparel, athletic uniforms, school spirit apparel, and related accessories. These products may or may not require embroidery, screen printing, or customization. Bid 24-24 contract pricing will be an option for all HCS Schools and Departments. Refer to section 2.0 Scope of Services for additional examples of the type of services and products included in this solicitation.
2.	Q2 - It looks like the same as bid 24-02 that we have already been awarded. Bid 24-02 runs through 6/30/2024, so I wanted to check to see if I need to fill out and submit this new bid 24-24, or is it the same thing and I can disregard this one?
Answer	Bid 24-24 is separate from Bid 24-02 which is specific to Physical Education related products. Bid 24-24 is intended to be a broader range of apparel and spirit related goods. We encourage Vendors eligible to provide products under the specifications of Bid 24-24 to submit a bid.

3.	Q3 - I have gone over the scope of the School Clothing Apparel, Athletic Uniforms and Accessories bid. However, I did not find any item specifications for an items. In section 2, 2.1 reads that a variety of products are to be submitted, can you clarify what items are being purchased now? A fee list is also requested, I assume for and embroidery. It is nearly impossible to list all items, there are so many. As well pricing is very dependent on what the decoration per garment. Is the goal to provide what brands each vendor carries and the individual schools or sections will reach out for pricing?
Answer	<p>This contract is intended to be open to a broad range of related goods. Some goods previously purchased include, but not limited to: Shirts, Backpacks, Blankets, Dye Sublimated Sports Uniforms, Screen Printed Garments, Embordered Garments, etc...</p> <p>As the opportunity for products is vast, HCS seeks a discount off industry standard manufacturer pricing by catalog or vendor's public facing fee sheet. There is no limit to the number of catalogs the Vendor may utilize or list.</p>
