We have reviewed the two bids received for the Revitalization of the West Center Street – Rotary Park Corridor Project received December 4, 2019. Cobb Site Development, Inc. at \$249,853.43, two hundred forty-nine thousand eight hundred fifty-three dollars and forty-three cents, and Excavation Point, Inc. at \$180,038.00, one hundred eighty thousand thirty-eight dollars. The apparent low bidder was Excavation Point, Inc. at \$180,038.00, one hundred eighty thousand thirty-eight dollars. While there is a moderate spread between the two bids, both contractors are experienced in this type of work. It is in our opinion that Excavation Point, Inc. has sufficient funds in their bid to do the work.

It is our recommendation and if you would like to proceed with the project, that the project be awarded to the low bidder Excavation Point, Inc. at \$180,038.00, one hundred eighty thousand thirty-eight dollars. If you have any questions please feel free to contact me at 863-385-5564.
