FAILURE TO DO SO MAY, AT THE OWNER'S DISCRETION, SUBJECT THE BIDDER TO DISQUALIFICATION

- 1) <u>QUESTION:</u> On page 01210-1 General Information- Courthouse Road- The line "After completion of milling activities, install recycled asphaltic concrete patch surface course, Type II, Gp 2 only with bitumastic material and H lime."
 - a. GDOT does not have an asphalt mix Type II. I think that for a 4" deep patch with surface mix you will want to use Recycled Asphaltic Concrete 12.5mm Superpave ANSWER: This was a cut and paste error. The new Quantities Sheet will reflect the correction.
- 2) <u>QUESTION:</u> Also page 01210-1 General Information- Bunyan Kessler- The line "After completion of milling activities, install recycled asphaltic concrete 12.5mm Superpave surface course, Type II, Gp 2 only with bitumastic material and H lime."
 - a. There is not a 12.5mm Superpave Type II asphalt mix. It is just Recycled Asphaltic Concrete 12.5mm Superpave
 - <u>ANSWER:</u> This was a cut and paste error. The new Quantities Sheet will reflect the correction.
- 3) QUESTION: Also page 01210-1 General Information- New Asphalt Parking Area- The line "Install prime and tack coats and place new 2.0" asphaltic concrete, DOT Type 9.5mm Superpave surface course."
 - a. Now for the GDOT 9.5mm asphalt they do have a type 1 and a type II. For parking lot I would think you would use the Type 1 mix
 - <u>ANSWER:</u> This was a cut and paste error. The new Quantities Sheet will reflect the correction.


